

With 50,000 more copies ready for printing and a load of free advertising from our censorial brigade, who knows just how many could eventually get their trembling hands on 'that wretched book'?







## TERITAGE CORNER.

Extract from the Weekly Courier (L'ton)
March 5th, 1905.

Oscar Larsen, the sole survivor of the crew of the barque Brief Holme, driven ashore and wrecked on the south-west coast of Tasmania on the night of November 5, was tendered a benefit by Mr. J.C. Bain, at the Temperance Hall, Hobart. The sum of £30.5.0 was realised. Larsen was also presented with an inscribed silver match box. Edward Noye, who rescued Larsen, was presented with a pair of binoculars. At the Albert Hall, Launceston, Larsen, who was accompanied by Haye, related his story to about 300 people, and was presented with a silver-mounted pipe. Noye was also given a pipe in recognition of his kindness to the survivor. The Brier Holme carried 20 hands.



#### IN THE EYE OF THE LAW

As the all-important Grand Final day approaches to climax a successful and interesting season's competition, plans will no doubt be made for celebrations by winning clubs, and those less fortunate.

While those in authority charged with the task of law enforcement have no desire to obstruct any such plans, so long as they are kept within lawful and reasonable bounds, it is strongly suggested that those persons who intend to drive their motor vehicles during the course of the resultant celebrations should keep in mind their responsibilities as road users, and do nothing that may result in unpleasantness or even injury to themselves, or others.

As has been previously stressed per medium of this column, the Government has made extensive amendments to The Traffic Act to provide for extremely heavy penalties for persons convicted of driving under the influence of liquor in this State. Perusal of the daily court reports in the newspapers will show that Magistrates are implementing the provisions of the amendments, and fines of \$100.00 or more are not uncommon.

In a recent decision in the Supreme Court on an appeal by a person against the severity of a six month gaol sentence imposed in the Swansea Court on a charge of driving under the influence of liquor, the Chief Justice, in dismissing the appeal, expressed very forcibly the view that the Courts must take such action, to carry into effect the intention of the Government in making the legislation.

As the State Supreme Court is the yardstick by which law is interpreted and administered, it is suggested that all those persons who intend to imbibe, not do so to excess, but that they take heed of this warning from the Chief Justice, and to the community in general.

We will be pleased if we are able to report in the next issue that no serious incident resulted from Grand Final celebrations in this area.

In Rawnsley and Freeman the Bay have two good backmen who could cause Viney and Bye trouble. On the St Marys backline, Dean and Targett are in good form in the key positions.
