A cheap way to keep the locals happy?

Last Tuesday 12th October, 4 members of the working group established by the government in September 1999, to review access to services for people with lymphoedema in Tasmania, came to St Marys Health Centre.

This working group is charged with the "investigation of, and making recommendations on, the availability and accessibility of lymphoedema treatment in Tasmania", with particular reference to a laser based in St Marys Health Centre and resources available to commence treatment of lymphoedema utilising the laser.

They met with us, Patsy Burgess St Marys Health Centre Manager, Shelagh Lowe Physiotherapist, Betty Silbey, Beryl Watson St Helens, and myself (Jan Sparkes) St Marys, as part of the fund raising team for the bio-stimulation laser for St Marys.

We looked at fundraising for the laser, allocation of space, allocation of staff, time, other resources, training of staff, registration of equipment, clients utilising the service, future service demands.

The outcome of the meeting — St Marys not a Tasmanian Lymphoedema Clinic, but revised to a "pilot project focussing on the needs of the people within Shelagh's current patient catchment area (Coles Bay to St Helens and along the Fingal Valley towards Avoca)."

A cheap way to keep the locals happy!


The St Marys Rural Transaction Centre will be opened at 11am on the 4th November 1999 by the Federal minister for Transport and Regional Services, Senator Ian Macdonald. This will be followed by a reception and free barbecue at Todd's Hall at midday. All welcome.

What is a Rural Transaction Centre?

Rural Transaction Centres are an initiative set up by the Federal Government to assist rural areas to maintain and attract financial and social services to areas that would otherwise lose these services. Funding is given for the construction or renovation of existing premises to enable them to provide a wide range of services, for example, banking, bill payments, financial advice, Medicare access, information and assistance. Funds are also given to develop research around communities financial needs before developing actual centres. The Centres are encouraged to co-locate existing services to make rural businesses more viable. In the case of St Marys the co-location of banking services will be in the Licenced Post Office.

Funding: A total amount of \$84,000 was granted to SMACD, the majority of this money will be spent on refurbishment of the telephone room, with a smaller amount of \$5000 being spent to advertise the project and to develop a web page and the town. Money not spent, is to be returned to the Commonwealth

OPPOSITION SCAREMONGERING ON COAL

The State government has accused the Opposition of trying to scare the Fingal community about the future of the coal industry in Tasmania.

Deputy Premier, Paul Lennon said there was no justification for this scaremongering.

"Mr Hidding's claim about the effect on the coal industry from the gas project appear to be nothing more than scare tactics.

"The Government does not expect that bringing gas to Tasmania will cause the demise of the coal industry.

"Mr Hidding is clearly playing politics with the issue of natural gas.

"This issue is of crucial importance to the future of Tasmania. The Government expects that bringing natural gas to the State will expand the economy, not contract it.

"What Rene Hidding is doing is attempting to undermine the gas project.

Patterns to break

Every time we interact with another person we set some form of pattern. In a marital or defacto situation this is intensely private and intimate with great expectations and hopes attached to it. So when it goes wrong, it has a far more devastating effect on adults and therefore children.

Separation, whether it be marital or defacto can be extremely painful and traumatic for all concerned. Sad though it might be for the adults, it is an emotional burden on children that can leave deep emotional scars.

I say can, not does, because the depth of scarring depends on the way in which the parents, or other significant adults, deal with the situation after separation. Generally speaking, if the same behaviour continues with the same arguments between parents and the way in which they deal with each other, then the same pattern continues between them. In fact it can be even more destructive, for while the parents were still together at least they didn't have the added problem of who caused the breakdown, together with the guilt/anger of the party who left, or the hurt/anger of the one who was rejected.

Separation is a confusing and painful time for parents but children often get caught up in the turmoil and used as weapons. The following is a vignette which gives an example of the kind of ongoing patterns damaging to children.

The children, quite innocently, aged three and four, go to see Dad for the weekend. They have a great time with him for although he tends to be a bit on the insensitive side, he's good with his kids and gives them lots of attention. But he still harbours resentment and anger towards their mother for leaving him. He entirely blames her and cannot, or will not, see anything in his own behaviour that could have prompted her departure. So as the children are about to leave after the weekend, an emotional time for him, he refers to her as a 'dog'. The children, quite innocently, although they picked up on the tone of Dad's voice, told Mum what he'd said. At their age, they had no idea of the meaning and were prophably expecting a reassuring response fron Mum that would ease their concerns about the tone in which Dad spoke of her. Mum however, reacted immediately and defensively. She was indignant, furious even and her response involved a lot of defamation of Dad's character. The pattern continued. Dad, whether intentionally or not, pushed her button to control her and she, without understanding what part she was playing to reinforce his stance, let him.

Of course, some will agree with Mum and say Dad should be stopped from saying what he's saying or from seeing the children, or punished etc. Or there are those who might say Dad has a point and was only stating the 'truth' that she had no right to leave him, that she is an immoral woman and shouldn't be caring for children, etc. But it has been shown that to go down this track of right and wrong, apportioning blame, and how to stop either doing what they are doing, is futile and in the long run just as damaging, if not more so, to the children. When a pattern like this continues, children learn negative ways to deal with others. They are in a position to learn manipulation, control and probably emotional blackmail. They also have to work out ways to minimize the harm and discomfort to themselves as they move from one parent to the other, attempting to deal with their conflict of loyalty.

The ideal and most effective solution is for both parents to put aside their own differences and work out what is in the best interests of their dhildren. But we often fall far short of ideals. The second best option is for one parent to understand the pattern of interaction and break that pattern unilaterally. If it takes two to play a game, then once one stops, so does the game.

In this case Mum was the one more open to change for the sake of the children. So she is the one who will need to alter her response, despite her own strong feelings. In the case of the 'dog' episode, her response could have been 'oh that's nice dear. I wonder what kind of dog I could be. I like dogs, don't you? How about a Poodle, Great dane, Doberman? What do you think I could be?

The result of this kind of response is likely to be that Dad's denigration of Mum falls flat, has no desired effect and ultimately could make him feel uncomfortable. The children then learn a different and more constructive lesson from Mum. If she continues this change of response in other instances where previously she would have been defensive, the pattern will be forced to change in some way. At the very least, the children will learn from Mum a different way of dealing with conflict, even though Dad may continue with his behaviour. One side effect could be that Dad lets go of his resentment and gradually mellows to the situation freeing up more positive emotional energy for his children. Also if Mum can learn the strategies of change (which, I might add are much easier said than done) and if she also learns to control her own behaviour and the situation, then there is a good chance of embracing her self esteem. In this case, the parents could be slowly and tentively moving towards the ideal of constructive co-parenting.

Changing patterns can be useful in all areas of life, if we recognise the part we play and learn to change that. However even when we are rational and calm, making a shift for the better in our response to others takes practice. It is a big ask for couples separating who are extremely emotional. But if damage to children is to be minimised, these patterns must be

broken and this, however difficult it may seem, is achievable.

(The above is an amalgam of behaviour in general and any resemblance to persons reading this is purely accidental)

VEGETABLE LASAGNE

8 lasagne sheets

1 cup each diced carrots, sliced mushrooms, diced pumpkin, sliced celery, small broccoli florets, diced capsicum 1/2 cup frozen peas

1/2 cup frozen corn niblets 1 teaspoon crushed garlic

1 onion diced

1 x 300g can Tomato Supreme 500g low fat cottage cheese

1 cup tomato past

1 tablespoon basil

Cracked pepper (optional)

1/3 cup grated parmesan cheese

1/4 cup extra grated parmesan cheese

Preheat oven 180°C. Microwave vegetables, except mushrooms on high for 8 minutes, drain. mushrooms, garlic, pepper and tomato supreme to cooked vegetables. Leave mix to one side. In a medium bowl combine cottage cheese, basil, 1/2 cup parmesan cheese and tomato paste. Coat a large lasagne dish with cooking spray, spread 1/3 of vegetable mixture over base. Top with 4 lasagne sheets, spread 1/2 of vegetable mix on top, cover with 1/2 cottage cheese mixture. Repeat this step again. Sprinkle extra parmesan cheese evenly over top. Cover with foil. Bake for 35-40 minutes, remove foil, cook a further 5 - 10 minutes till cheese is golden brown

POOL MEETING REPORT TUESDAY 12TH OCTOBER 1999

On Tuesday 12th October, there was a meeting at St. Marys District High School regarding the costs and usage of the pool for the 1999-2000 season. Flyers were sent home to all students the week before and the meeting was publicised in the Valley Voice. Over 20 interested people attended and after much discussion and input by the group present the following costs were detailed and issues brought up for consideration.

FINANCES - PAYMENT SYSTEM FOR 1999/2000

- KEYHOLDERS ONLY: \$135.00 (approx. depending on price of resuscitation mask details below about this) with \$10.00 refund at return
- KEYHOLDERS AND Learn-to-swim/Squad sessions: \$130.00 + \$2.50 per session.
- Learn-to-swim/Squad sessions ONLY: \$3.00 per session

THE P&F WILL AGAIN CO-ORDINATE THE HOLIDAY TAS SWIM PROGRAMME THIS SEASON.

It was felt that those who only participated in the swimming tuition paid for the tuition ONLY and not for the running of the pool - power, heating, chemicals, etc., resulting in people actually using the pool for free. 50 cents from the \$3.00 fee will go to pool costs.

The group felt very strongly that there were quite a number of people abusing the present pool system and after much discussion the following guidelines were set for 1999/2000 season and beyond and ALL users of the pool are expected to bide by these guidelines.

- SMOKING and ALCOHOL are NOT permitted under ANY circumstances on the school property, particularly in the vicinity of the pool. This occurred last year several times. Signs will be purchased and erected to support this.
- It was felt that parents who remained in their cars or dropped their children off at the pool then left, or simply did not observe while their children were in the water, were not providing enough supervision of their children. ALL parents or a NOMINATED guardian MUST be AT the pool providing VIGILANT supervision. It is not the responsibility of other parents.
- Students are STILL required to remain OUTSIDE the pool gate until a parent/guardian is with them (or their swimming coach). There should be NO UNSUPERIORED CHILDREN IN THE POOL AREA OR IN THE WATER. be NO UNSUPERVISED CHILDREN IN THE POOL AREA OR IN THE WATER.
- If children are in the water for swimming sessions ONLY and they are NOT a KEYHOLDER, they are NOT entitled to remain in the water after their lesson is over. Nor are other family members /friends/relatives allowed in the water during this tuition time.
- The STAYING OVER/GUEST rule basically works on an honesty system. Invited guests/family etc. are welcome on a short term basis but not people just trying to get free swims.
- It was felt that large toys, balls being thrown and some toys were inappropriate because they were either dangerous to others or there simply was not the room. Please be considerate when bringing aquatic play things and consider the safety of others. BIKES were also mentioned and are NOT to be brought into the pool area. NO GLASS drink bottles or other unsafe items are to be brought into the pool either.
- Of great concern was the NUMBER of children some people seem to have at the pool. It was mentioned that some parents are taking their own children plus family members and friends' children all at once and the question was asked "WHAT CONSTITUTES A FAMILY when purchasing a key?". It was suggested that some times there are so many children with one adult, the supervision is simply not adequate. No number limit of children per adult could be set but those at the meeting requested that adults use common sense about the number of children they could SAFELY observe 100% of the time.
- POOL COVERS are to be put on by the last swimmers leaving each day.
- It was unanimous that ALL keyholders will be required to purchase a small fold-up resuscitation mask to be attached to their pool key. THIS IS CURRENTLY BEING LOOKED INTO. The cost is expected to be \$4.00-\$5.00.
- 10. Safety equipment will be attached to the inside of the shelter area (rope, stick, kickboard, whistle) for EMERGENCY USE ONLY. 3 long loud blows on the whistle indicates an emergency-everyone OUT!
- 11. Access to a phone at the pool is being looked into.

We thank all those who attended this positive meeting and the pool will be opening in a few weeks time.

The Swimming Pool will be open for family and community use some time in the first week of November 1999 until mid April 2000. Definite opening date will be advised later. The cost of keys for this season will be \$130.00 (\$120.00 fee and \$10.00 key deposit - refundable on return).

As this is an unsupervised pool, each keyholder and any "designated adult" (meeting the criteria stated in the rules) supervising swimmers must have a current CPR or First Aid Certificate. The school will co-ordinate CPR Certificated Courses (valid for three years) if there is a need. Times and costs for these courses will be advised as soon as details become available. If you are interested in attending a course, please leave your name and contact number at the office.

Keys and rules will be available from the office from Monday 18 OCTOBER. When collecting keys, please ensure that you have your valid CPR / First Aid Certificate with you for us to copy and keep with your key application form.





Joseph Ebeneezer Clarke Joseph who?

J E Clarke was a leading property developer in early St Marys, responsible for the building of a substantial proportion of 'the Block'. The CBD of the township comprised of Main St - Storey St - Groom St - Cameron St. In particular he built many of the cottages in Storey and Groom Streets and a 'store and house' in Main Street which was first Cramps, eventually H.C.Dawborns, Sams, and now St Marys Supermarket.

Clarke first appeared in local records in 1869, occupying a shop and premises in Talbot St. Fingal, later to become Holder Bros.

He was 40, married to Eliza, with a daughter Amy who had been born two years earlier in Launceston. By 1872 he was also renting a shop and house at Mathinna, and in 1876 he was the owner of 3 acres 1 rod 22 perches of land in the slowly developing township of St Marys at the head of the Break O'Day Plains, land which was to be the site of a store which would serve St Marys over three centuries.

Between 1876 - 1881 Joseph Clarke was involved in multiple land dealings, mainly in Fingal, but all the time operating the Talbot Street shop and retaining his township land in St Marys, anticipating the growth that would result with the opening of new coal mines and the arrival of the railway line in 1886.

That these developments were not confirmed by current newspaper reports, even as late as 1885, "some people think the railway will ruin St Marys, others think it will make it. Even if the Mount Nicholas coal mine goes ahead, it will not benefit St Marys as the colliers will have their own township close to the workings" J.E.Clarke however backed his beliefs on the future of the town.

Sometime during 1881, Clarke built a house and store on the 3.1.22 acres in Main Street and the next year leased it to J.T.Cramp. Cramp sold the shop on 1.1.0 acres that he was already operating, to George D'Embden, and moved into the new and bigger premises.

Soon after, Clarke gave up the Talbot St shop in Fingal and by 1885 he was living in St Marys.

With his builder Joseph Cooper, he started an intensive development programme that was to put their mark on St Marys and established 'the Block' (or 'the Square') as the centre of the town.


The 'Country Correspondent' wrote for The Examiner on 2nd October 1885, "Mr J. E. Clarke's two cottages, one finished and timber being drawn and placed on the ground for the two more dwellings and from what I can glean, they are to be different in design. Mr Clarke is making the best use of his small allotment and also improving St Marys. In fact ever since Mr Clarke purchased land here he has made improvements. No one else would erect a building but now buildings are going up in a good many places"

By mid 1889 Joseph Clarke owned 15 properties on 'the Block', 11 cottages in Storey and Groom Streets.

The Storey Street properties faced east to the Wesleyan Parsonage, Chapel, stables and Assembly Rooms across the road and the cottages faced south where G.R.Napier had his store and house and Bernard Madden and James Cooper occupied their cottages on bigger blocks than the new cottages of Clarke.

The Sale Yards on 1 acre and owned by William Lade were at the western end of 'the Block' on Cameron Street.

However by 1889, Clarke was no longer resident in St Marys. In fact since 1887 only two years after he started his development of 'the Block', he had been J.E. Clarke of 'Farnham' Elphin Road Launceston.

In 1888 his 15 year old son Sydney Herbert, born in Fingal in 1873 died at Launceston. Whether it was in response to personel tragedy (and he was after all a proven property developer and he was now 60 years old). Joseph Clarke started to release his property

holdings in St Marys and reap the return for his belief in the future of the town.

He started by subdividing his earliest holding in the town, the 3.1.22 acres in Main Road containing the store leased by T.J.Cramp. He sold the store, house and the remaining 2 acres to Cramp and by 1890 he had sold all his commercial properties to his occupying tennants, as well as four of the cottages, and had tennants in the remaining cottages listed as 1 to 7 in Groom and Storey Streets.

Most of these tennants appeared to be called George I: George Stevens in cottage No 1, George Button (No 2), George Williams (No 4) and George Edwards (No 5). Price in No 6 seemed to have no christian name, but as either Miss Fanny Toby (No 3) or Edward Newman (No 7) passed their neighbours, the street must have echoed with "morning George"!

By 1892 he had also sold cottages 1-7 to among others, Mrs Charles Oliver, William Dennis, John King and Miss Margaret Harrison.

J.E.Clarke was no longer listed as a property owner in St Marys.

Joseph Ebeneezer Clarke died in Launceston on 12 April 1904 aged 75 and was buried in the

Cypress Street Cemetery.

Although a property owner in the town since 1876 he was resident for only 3 years or so, nevertheless he believed in the future of the town and his drive and enthusiasm was recognised at the time.

The 19th century cottages of Joseph Clarke and Joseph Cooper in Groom and Storey Street and his store in Main Street, still stand as we move into the year 2000, "improvements" which

will span three centuries in St Marys.


