MANGANA FIELD DAY

St Patricks Head & Esk Valley Historical Society Inc. held a field day to the history rich town of Mangana on Sunday the 15th March.

Twenty or so adults and children met at the beautifully constructed Our Lady of the Sacred Heart Catholic Church in

the Main Street of Mangana and after a tour of the 97 year old church by Society President, Barry Aulich, we all moved to Warren and Debbie Speers' block around the corner for a BBQ lunch.

Over lunch, Warren gave us a detailed talk on the history of Mangana where gold was found by convict shepherd, Keeling Richardson, in 1852. To back up Warren's talk, Debbie produced a folder full of old Mangana family photos dating back to the 1800s when the town had three hotels.

After lunch we all headed into "gold country", where we found a likely looking creek and Peter Rubenach guided the group in the art of gold panning.

The day finished with Warren guiding us to several old tunnels and shafts, most of which were driven before the turn of the twentieth century and are still in fair condition.

Did we find any gold you may ask? The answer is: Yes we did. But before you go racing off to Mangana with your shovel and pan, it will most likely take you a whole year to make enough for a cup of coffee.

A LITTLE BIT OF HERITAGE: Jim Haas

"The last chatelaine of Malahide Castle"
1915 - 2009

A few issues ago I wrote about William Talbot, who left the comfort of his family home at Malahide Castle in County Fingal, Ireland in 1820 and eventually ended up with a land grant at the junctions of the South Esk and Break O'Day Rivers in Van Diemens Land.

With the recent passing away of Rose Talbot, I thought it appropriate to write a little more about the Talbot family and their contribution to the development of the Fingal Valley.

William Talbot was given his grant in 1824 and in 1827 named it "Malahide" after his home near Dublin and the town which sprung up around his property he named Fingal after his Homeland County.

Although William married he never had children and after his death in 1845 his now thriving sheep, cattle and crop property was left to his nephew Samuel.

In the early 1900s, Lord Milo Talbot took over the Malahide dynasty and although widely travelled as a collector of plants for his botanic gardens, he had not visited Tasmania until he heard of a local landowner who was offering to buy his property. But when Milo arrived at his Tasmanian "Malahide" he refused the offer and instead of selling, invested in the properly by first restoring the old homestead, and with no expense spared. From then onwards he spent most of the British winters at Fingal.

Milo was the last Lord de Malahide and died unmarried in 1973 and all his inheritance went to his sister Rose, who also never married.

Rose Talbot was the last member of her family to live at Malahide Castle, which had been the family home since 1185. After her brother's death she was besieged with death duties and was forced to surrender the property and sell the contents in 1976. Desmond Guinness of the Irish Georgian Society said: "Every item was a priceless gem."

Rose fought a gallant battle to keep it all as a family residence, but she received no help from the Irish Government who, at the time, saw it as Protestant ascendancy. Later Governments recognised the error and they now give encouragement to owners of grand houses to stay in their home and have even tried to reassemble family treasurers that have been dispersed throughout the world; too late, however, for the Talbot's unique collection of Irish, Georgian furniture.


By now Rose was a spinster in her sixties, but bravely, she packed the little she had left and moved half way around the world to make a new life at another Malahide, in the town of Fingal, Tasmania.

Rose was a somewhat shy lady, but she soon established herself as a prodigious networker in Australia by travelling the vast continent and getting to know its most influential movers and shakers. She also kept in touch with her friends in the northern hemisphere by letter and a grand tour of the British Isles every summer.


Rose was a generous lady and gave to many charities, but her love of horticulture is what captured her interest the most. Soon after arriving in Tasmania, she completed the commissioning of a series of books started by her brother before his death. They were: The Endemic Flora of Tasmania, written by Dr Winifred Curtis and illustrated by Margaret Stone. Among her English horticultural friends to travel to Fingal were Lady Salisbury of Hatfield and Lady O'Neill, wife of the former Prime Minister of Northern Ireland. Anne O'Neill had known Rose since their youthful encounters at debutante balls and joked that what they had in common was being wallflowers together. Their knowledge of rare plants, however, was prolific.

Rose's last years were spent quietly at her "Malahide" in Tasmania. She passed away peacefully on the 14 February 2009 at the age of 93, and was laid to rest at a humble ceremony in the Fingal Anglican Cemetery. One could never measure the enormous contribution she and the Talbot family have made to the Fingal Valley since William's arrival in 1827.

We can only hope the new heir, Rose's cousin, British Naval Officer Richard Talbot, will continue running "Malahide" in the traditions of its pioneer, and like his predecessors, fall in love with the unique beauty of this part of the world and make the grand old mansion his home.

I would like to thank Charles Trollope for his article of 'Valley Voice', March 12.

Parts of it surprised me. His statement, "Councils are part of the crown, unlike state and federal governments", made me wonder which planet he is on.

Section 1 of our Constitution states:

The Legislative power of the Commonwealth shall be vested in a Federal Parliament, which shall consist of the Queen, a Senate and a House of Representatives, which is here-on called 'The Parliament' or 'The Parliament of the Commonwealth'.

Section V deals with States. Section VI with new states. It recognises States.

To quote from Australia's Commonwealth Parliament – 1901 –1988 Ten Perspectives, by G.S.Reid and Martyn Forrest: "Section 1 is, undoubtedly, the foundation provision of Australia's political arrangements. Not only does it specify the tripartite composition of 'The Parliament' but it also vests the whole trinity—Queen, Senate and House of Representatives—with the legislative power of the commonwealth."

Mr Trollope is keen to highlight the work of Justice Issac Issacs.

In the case of the 'Amalgamated Society of Engineers V. Adelaide Steamship Co. Ltd', (1922) Commonwealth Law Reports, Justice Issacs stated: "The theory that ministers execute the Royal Will, accommodates itself to the fact that the Royal Will is to do what <u>Parliament</u> desires."

In paragraph 7 of Mr Trollope's article, he mentions a book by Quick and Garran.

In Australia in 1901, members of the new commonwealth parliament also had available to guide them the important joint work of Sir John Quick (Professor, Bendigo) and Sir Robert Randolph Garran. (later Solicitor General)

The volume was called "The annotated Constitution of the Australian Commonwealth." It was not the act itself. The act of the constitution recognises the states, and I for one, would like to deal with state issues at state level. There is a state ombudsman to deal with grievances between individuals and government departments.

When we pay our rate monies to our council we are acknowledging their right to enforce council laws and by-laws.

Our parliamentary history is indeed interesting, but we should be aware that women did not have the right to vote until 1902.

Our aboriginal population wasn't even counted as part of our population and given citizen rights until the referendum of May, 1967.

Under federal drug laws a warrant may not be required to enter your premises or search your car.

Tasmanians have a lot more say and freedoms in this day and age since the first colonial order was put into print by Lieutenant-Governor David Collins, on the banks of the Derwent, February 20, 1804. (Historical records of Australia, Vol. V. page 233.)

Forget the Rife Machine Charles, stick to the electric fence!

The removal of the wall from around St Marys Cenotaph distresses me, and especially as the removal was sudden, and I believe unannounced to the public.

I do not know the legality of the removal, but I am concerned about the morality.

I believe a Cenotaph not only honours our heroes, but is a symbol of democracy, and therefore the Cenotaph and the immediate surroundings is an honoured, reverent and special place.

I have always felt that a town's Cenotaph is public property. Am I wrong with this assumption?

My father and my other family members fought for democracy—democracy so I and my children and following generations could freely voice their personal ideas, ideals and beliefs without fear of retribution or suppression, so I am voicing my democratic right today—I believe it was morally wrong to interfere with the St Marys Cenotaph without informing and consulting the public

Personally, I found the Cenotaph as it was, a unique, special and reverent place. What will the 'new look' be like? Who has seen the plans and why were the 'new look' plans not on display for public comment prior to commencement of work at the cenotaph?



BREAK O'DAY COUNCIL RECEIVES \$2,265,506 IN FEDERAL GOVERNMENT ROAD FUNDING

Dick Adams, Federal member for Lyons, recently announced that the Break O'Day Council would receive \$2,265,506 over 5 years from the Rudd Government through the *Roads to Recovery* Program.

"This Federal funding will not only help to maintain and upgrade our local roads, it will also support local jobs and businesses during the current global recession.

"Local roads are very important in regional communities, whether it's travelling to town or work, this funding from the Rudd Government in partnership with local councils will help to deliver safer roads for everyone," Mr Adams said.

Last year, the Rudd Labor Government extended the program for a further year, and boosted its total funding to \$1.75 billion – an extra \$250 million when compared with the previous government's allocation.

These funding allocations are based on the recommendations of State Local Government grants commissions.

"This funding is untied, with councils able to spend their allocations on the local priorities identified by local communities.

"I urge communities contact their councils and help identify areas of local need for this funding," Dick Adams said.



At the council meeting on 10 March 2009, a ratepayer sort a remission of a water bill of over \$1000, because a tree on their property had grown around the water pipe leading into the home. This remission was declined as the problem was on the ratepayer's property. There is a lesson in this. If you are a shack owner or are leaving your home for some time then **TURN OFF** your water at the meter. This action could save you money.

A petition from Scamander residents for a footpath was received and this will be considered at the upcoming Budget deliberations.

The Council supported a motion to remit all Council rates and charges (excluding fire levy) to those ratepayers holding Crown leases/licenses for boatsheds under certain conditions. If you have any questions on the decision please contact the relevant Council Officer.

Cllr Legge submitted a motion to reaffirm the Council's decision to appose aerial spraying, because of the inherent health hazards. This motion was lost with only Cllrs Clement, Harper and Johns in support.

Cllr Harper's motion on WIFI Broadband was carried unanimously and this is to invite Expressions of Interest from suitable telecommunications carriers to provide a public WiFi service.

Cllr Clements motion to form a St Helens Town Council was lost only Cllrs Clement, Harper and Johns in support.

Cllr Clement asked two questions on notice

1. When will the General Managers position be advertised?

2. What progress has been in providing solar lighting along St Helens Foreshore footpath?

Cllr Clement asked one question without notice

1. About the unsuccessful amalgamation with Glenmorgan spring Bay.

Cllr Johns asked one question without notice

- 1. If the Mayor has stopped the demolition of the old club rooms at Mathinna?
- 2. What is the Council policy on replying to correspondence?



Understorey Network News

The Understorey Network is a group of individuals from all walks of life around Tasmania, who believe that the understorey is important. We promote the protection of existing native vegetation, and the use of local native understorey in revegetation. We are an independent and not-for-profit community organisation. We are always looking for new members to join the recently formed North East Understorey Network Branch.

We meet quarterly and run field trips and workshops to show people how to identify plants, collect seeds and grow seedlings. Members collect local native seeds and grow them into seedlings for use in revegetation projects. If you are interested in learning more about the Understorey Network and our activities please call Janet Drummond on 6372 2851.

Locally the Understorey Network members grow plants for revegetating Wombat Walk in St Marys and private landowners. You can join as a grower or as a local landowner wishing to have plants grown for you.

Visit to Winifred Curtis Reserve, Scamander by the North East Understorey Network Branch.

In May 2003 the Protected Areas on Private Land Program reserved a property near Scamander on Tasmania's East Coast. Through this covenant 75 hectares of coastal vegetation is now permanently protected by the 'Winifred Curtis Trust'. This land is now a privately owned nature reserve, the first of its type in the Break O'Day Municipality.

On 1st February 2009 the North East Understorey Network Branch met with Paul Fratter a member of the Winifred Curtis Trust and a local horticulturalist with great knowledge of the reserve, and Tim Rudman who is an expert in the field of Managing Phytopthera at the Winifred Curtis Reserve.

The group arrived mid morning and thoroughly enjoyed learning much about the vegetation in the Reserve from Paul Fratter. Paul was most happy to answer questions about the plants that were seen there and had a wonderful depth and breadth of knowledge to share with us all.

Secondly, but in no way any less important, Tim Rudman took us through the Reserve and in particular to a

Phytopthera front to show the group the healthy vegetation, the front moving through and the trail of dead plants left in the wake of the Phytophera disease taking hold. Tim discussed management techniques and spoke of the work being done in many areas in an attempt to learn as much as possible about this disease. He illustrated to us, plants that would survive the Phytophera and plants that could not survive the Phytophera.

In all about one dozen members greatly enjoyed this very educational morning and took away much information of importance with them that will assist in managing their own properties and also in increasing our knowledge about the disease of Phytopthera.

The North East Understorey Network Branch would like to take this chance to again thank both Tim and Paul for a really enjoyable and educational morning.

St Marys Police report

Easter is fast approaching, myself and the other officers in the valley are looking forward to a peaceful and accident free holiday period. With this in mind I would like to remind all road users' safety issues concerning our roads.

I would ask that drivers observe the sign posted speed limits and any precautionary signs especially in area that road works are being conducted. The imposed speed limits at road works are not only to keep you safe due to the condition of the road surface but also to provide the workers at those sites with a safe working environment. Further, if speed limit signs remain displayed at night they still apply.

It has been all too obvious with the end of daylight saving and the recent cold weather that winter quickly approaches. Drivers are reminded to turn their lights on early towards dusk and also in inclement weather. It is worth noting that with the advent of the Road Rules 1999 it is not just advisable to turn headlights on in inclement weather, it is a requirement of the legislation.

With the Easter break expect to see increased police operations. In particular police will continue to target the main contributing factors in serious injury accidents. Namely drink driving, speeding, failing to wear seat belts and inattentive driving. Inattentive driving includes such things as using mobile phones, failing to indicate and disobeying road signs.

However, the Easter break in the Break O'Day Municipality not only brings an increase of traffic to our roads but also the increase usage of our waters. If you plan on using your vessel over the period please ensure you do so responsibly and with consideration for others. You should also ensure that you are carrying the required minimum safety equipment. Random checks of vessels, including safety equipment carried will be conducted at ramps and at sea.

Tasmania police can also random breath test vessel owner and operators with a 0.05 limit applying on the water just like the road. Additionally, one person on your motor boat must possess a speed boat licence and the boat is required to be registered. Please find below a list of safety equipment for your motor boat.

- All passengers in a vessel under 6m must wear an approved life jacket whilst the boat is under way
- Children under 12 in any vessel must wear an approved life jacket whilst the boat is under way
- Carry an auxiliary method of propulsion (i.e. oars or second motor)
- A fire extinguisher
- A bailing bucket
- Anchor and chain
- Flare kit (not required for smooth waters) consisting of a minimum of 2 x orange smoke flares and 2 x red flares (sheltered waters). You will also need 2 x parachute flares if you are going more than 3 nautical miles to sea.
- A marine radio if you are going more than 3 nautical miles to sea.
- An EPIRB if you are going more than 3 nautical miles to sea

Our plans have been submitted for our extension, all fingers are crossed. Guild members will actually be doing the construction to limit any costs to the community.



Successful applicants will take up their role in late April 2009.



Further Drought Assistance Package

The impacts of the persisting drought in parts of Tasmania are being tackled with an additional suite of measures to assist affected communities.

The Minister for Primary Industries and Water, David Llewellyn, recently announced that the Tasmanian Drought Taskforce has provided advice to Government on extending existing support and the introduction of new assistance measures.

"Even if the global financial crisis places limits on what can be offered, it remains appropriate to expect support for both communities and individual enterprises suffering from the prolonged dry conditions," Mr Llewellyn said.

"The measures announced today focus primarily on helping with the community impact of the drought, and extend assistance through to the end of June.

"Business-related support and continuation of the community and social support packages will be developed as part of the budget process in line with the commitments of the Premier during the State of the State address."

Drought Package summary:

Small grants program - CWA:

The Country Women's Association will receive an additional \$100,000 to continue its distribution of small grants to households in need. The grants can be used to pay family bills such as power, clothing, school and similar expenses and will be a welcome supplement to Centrelink benefits. Already, \$115,000 has been provided to the CWA for these grants since May 2008.

Community events and forums - TFGA:

The Drought Task Force highlighted the benefit of community-based events, especially those which linked people with service-providers offering support. A number of successful events were held on Flinders Island and in the Midlands over the past year. The Drought Network will work to identify opportunities and areas for the events, and the Tasmanian Farmers and Graziers Association will receive \$100,000 to organise and run them.

Rural Financial Counselling (RFC) and Rural Alive and Well (RAW):

Considerable suffering results from the prolonged impact of the drought on household finances and personal well-being. RAW will receive a further \$50,000 in addition to the \$165,000 already provided, enabling it to extend is mental health work to the East coast. RFC will be supported with a further \$45,000 in recognition that the need for its services is continuing. This is in addition to the \$115,000 already provided.

Flinders Island Water Monitoring:

Flinders Island farmers are heavily dependent on groundwater resources for essential farming needs. There are concerns that these resources have been drawn down because of the drought. DPIW and the Flinders Council will work together on a groundwater assessment of the island. \$80,000 has been allocated for this purpose.

Flinders Freight Equalisation Scheme

The Commonwealth's Tasmanian Freight Equalisation Scheme largely offsets the costs of transport to and from Flinders Island. However, real differences exist between the cost of primary production on Flinders Island and equivalent production costs on mainland Tasmania. \$100,000 will be offered during the first half of calendar year 2009 to assist with the cost of transporting feed to the island, so that this cost is no more than for a similar road distance within mainland Tasmania.

Mr Llewellyn said that the measures just announced are all aimed at community or regional assistance for drought-afflicted areas.

"However, individual businesses will stand to benefit from three new measures which are being refined as part of the budget development process. This further assistance for individual enterprises will be consistent with commitments in the Premier's State of the State address.

"Producers will have access to loan funds to invest in infrastructure associated with irrigation through reactivation of the provisions of the Farm Water Development Act 1985."

In addition, dollar for dollar funding will be provided through an extension of the Enterprise Growth Program to allow eligible farmers to develop drought recovery programs.

Further support will be offered through loan funds by extending the Tasmanian Industry Support Scheme to allow eligible farmers access to capital for restocking or re-pasturing if they have been denied funds from mainstream financial institutions.

These three individual business assistance measures will be administered through the Department of Economic Development and Tourism.

Mr Llewellyn commented that the measures being developed were consistent with the types of measures that would be available under the new National Drought Policy arrangements being developed by the Primary Industries Ministerial Council.

Mr Llewellyn thanked the Tasmanian Drought Taskforce for its work.

Water Licence Changes

The Department of Primary Industries and Water has started issuing the first 40-year water licences under changes designed to provide licensees, and their financial backers, with increased certainty and security.

David Llewellyn, the Minister for Primary Industries and Water, has announced that, in addition, most water licences will now be automatically renewed when they expire.

"The changes demonstrate the Government's willingness to respond to water users' needs for clearly-defined, certain and secure water access entitlements to underpin investment in Tasmania's water industry," Mr Llewellyn said.

"Up until recently, most water licences have generally been issued for 10 years, with the requirement that the licence holder apply for a renewal at the end of the tenure period. The 10-year term was needed to bed down the Water Management Act after it commenced in 2000.

"These arrangements appeared to have satisfied the needs of Tasmanian farmers quite well.

"You only have to drive around rural areas to see that irrigators have demonstrated a willingness to invest strongly in water-dependent development with new dams and centre pivot irrigation systems going onto farms all over the State."

Notwithstanding this visible evidence of investor and financier confidence, Mr Llewellyn said that the Government had become aware that there was a level of misunderstanding by some parties about the longer-term security of Tasmanian water access entitlements.

"Whilst I am pleased to say that the National Water Commission has formally confirmed that Tasmania's statutory water licensing and allocation system fully meets the requirements of the National Water Initiative, the Government is not prepared to rest on its laurels, so long as there are any concerns that could impact on the ability of farm businesses to obtain finance under favourable conditions.

"Now that the legislative process is settled, the tenure period for new licences will generally be 40 years, in order to better meet the security needs of commercial water users and their financiers.

"The Department is also currently developing a process to extend the tenure of existing licences, commencing with those due for renewal from the beginning of 2010."

Mr Llewellyn said that automatic licence renewal would cut out an unnecessary administrative task for licence holders. "Parliament recently amended the Water Management Act so that water licences will now be renewed automatically, as long as licensees have paid all their fees, complied with their licence conditions, and have not been disqualified from holding a licence.

"The Department expects that the vast majority of licensees will meet these conditions, and they will receive their licence renewal automatically."

Mr Llewellyn said that a number of licensees currently have outstanding fees and in these cases the Department will send invoices, which if paid immediately, will ensure that their licences are renewed.

All licence holders are being written to about the changes, as are the major financial institutions and the Australian Banking Association.

"It is important for licensees to note that the 40-year licence tenure period still provides the ability to suspend or cancel licences during this period if they fail to meet their obligations for compliance with licence conditions and the payment of annual licence fees."
