


Fire & Emergency Services Official Opening.

On Friday the new Fire and Emergency Services facility was officially opened by the Hon Jim Cox MP. Around 100 invited guests attended this very successful function.

' Rodney Read the Tas Fire Service former District Officer approached Michael Aulich in the late 1990s, saying "we are looking for a block of land in the main street of St Marys to build a new fire station on". I looked at Rodney at the time and said that is great, we would love a new station but unfortunately they don't make land anymore and the only vacant blocks in the main street are not for sale and not suitable for a fire station, Rodney just looked at me and said you will find something.

Well low and behold here we are now, on the site of the old shop owned by the infamous Stan Graham. For those that did not know Stan he was an icon of the area providing the community much entertainment with his method of displaying items for sale from here, old furniture would quite often cover the footpath and be spread halfway out into the street. Stan also owned and rented out a considerable number of houses in Cornwall and St Marys, these provided the Local Fire brigade with regular structural fire fighting practice throughout the year, and then unfortunately after Stan's passing the shop also met with a similar demise, ironically creating a vacant block in the main street to later become the

site of the new Fire and Emergency Services facilities. Rodney Read could start and fulfil his promise of building a new station. Unfortunately Rodney did not see his vision completed, passing away not long after the Tas Fire Service purchased the block of land.

In more recent times there has been considerable planning and negotiations occurring between the various parties and the combined emergency services facility that you see today is the result.

This co-location has proved quite successful to date, providing all services with much needed improved facilities and training facilities, which ultimately means the community is better protected, and served in times of need.



Tasmanian Ambulance Service:

The St Marys Ambulance service was established in the early 1970s through the efforts of the local community and the support of the Red Cross. Originally the service was based at the local hospital where community funds were raised and used for a shed that could house the local

ambulance. Red Cross volunteers were supported by nursing staff at the hospital. Tasmanian Ambulance Service (TAS) took over the function of operating the service back in 2000. TAS currently responds to around 300 calls per year out of St Marys, 100 of those being emergency incidents.

State Emergency Service:

The State Emergency Service (SES) officially started in 1988 as the Portland Unit and when the Portland and Fingal municipalities amalgamated in 1993 the Unit became known as the Break O'Day Unit. This unit has traditionally operated out of St Helens and continues to do so but SES saw the need to provide an improved response to communities in the Fingal Valley area and decided to establish a sub-unit located at St Marys. This centre and the one at St Helens go to make up the Break O'Day Unit.

Tasmanian Fire Service:

The Brigade was originally formed as the St Marys Rural Fire Brigade back in the early 60s with a handful of members operating out of Mr Jack Bullock's house, using Gerald Aulich's private car to transport equipment. The State fire commission was established in 1979 and over the ensuing years new fire equipment and trucks were gradually introduced through volunteer and community efforts, with assistance from TFS. In 1987 the original Fire Station was constructed and the brigade contin- Photos this page courtesy Peter Troode. ued to operate out of those premises until recently.

A LITTLE BIT OF FOOTY HERITAGE: Jim Haas

"George Oliver"

It was a fine Saturday in late March 1930, when a young sixteen year old farmer's son from Gray turned up at the St Marys football ground and asked for a game. Not much notice was taken of the lad at first; St Marys had plenty of good experienced players. They had won the Premiership the year before and, if you took notice of the supporters, they won the year before that, too. In 1928, Fingal had claimed the siren blew with ten minutes to go when St Marys kicked a goal to put them in front. A protest was lodged and the game was subsequently replayed the next week, with Fingal coming out winners by 5 points.

Despite the quantity and quality of players, the lad from Gray was given a go. It only took half a quarter, however, for everyone to realise that this skinny, five foot eight boy they called George, had as much football talent as anyone who had come before him.

George Oliver is 94 years old now, and the only person still alive who played in that 1930 Premiership side. The memories of his first year with St Marys and the Premiership win against arch rival Fingal by 20 points, are as vivid as ever. "I wasn't old enough to drink, but I was drunk until at least Wednesday," he says with a cheeky grin.

George went on to be a vital part of the St Marys team for the next twenty years; playing in four winning Premiership sides: 1930, 1939, 1946 and 1947. He finally hung up his boots in 1950 at the age of 37.

The best coach George reckons he had was a builder by the name of Pudner Lawrence, who came to the area to build an extension to the school. The Friday night before St Marys was to play Fingal for the 1930 Grand Final, Pudner called a team meeting. He admitted that Fingal had too much talent for St Marys and the only way to win was to start a fight.

By the end of the meeting the game plan was finalised, with Pudner volunteering to punch Fingal's star player in the first quarter. Sure enough he was a man of his word, before the first quarter was over not one, but two, Fingal players were laying on the turf and an all-in brawl erupted. In minutes the oval was a disaster area as supporters flowed onto the ground to join the players in what was to become a melee to be talked about for years to come. Order was finally restored and St Marys went on to win by 20 points.

Towards the end of the 1930s the Rovers folded and after St Marys beat Fingal in the 1939 Grand Final by 15 points, the Fingal District Football Association went into recess, due to World War Two.

The competition recommenced in 1945 with St Marys and Fingal again playing off for the Grand Final. This time Fingal took home the cup with a heart stopping 2 point win.

George has fond memories of the next two years when St Marys won back to back Premierships, defeating Avoca on both occasions. In the 1946 Final, George flew over the pack to take a spectacular mark, but as he did someone grabbed

his shorts and tore them clean off. Did this deter George? No, he took off with the ball and entertained the crowd with a fine display of goal kicking, bare ass and crown jewels.


In those days, the half-time break meant a nip of rum and half an orange. One day someone put training oil in a rum bottle and a star player of the day raced into the sheds and grabbed the first bottle he saw. Needless to say the coach had no hope of extracting his star from the outhouse for the rest of the


George says he is honoured to have played footy with players in the class of: Stan Salter, Ted Guard, Bill Mitchell, Harry Shepherd, Stan and Kelly Birrell, Doug Nolan, Roy Cocker, Ron Lohrey, Peter Davern, the Bolton Brothers and Brindle Bradbury to name a few. But he reckons the best would have been Ivan (Johnson) Bean. Johnson went to Longford for a few years, during which time he made the Tasmanian State Team. But then George himself must have been okay, he went to Hobart to join a Tasmanian squad to go to Western Australia, but came down with the flu the day they were due to fly out and couldn't make it.

George's story is one of hundreds that make up the history of the St Marys Football Club. These are stories of young men who become local he-

roes by building a character full of sportsmanship and courage that carried on in every facet of their lives.

In any town football is a significant part of the community history. Let us all get behind the current committee so that footy history in our community can continue and not just be a bunch of images stuck on a wall.









THE YEARS THE TIGERS ROARED THE LOUDEST: Jim Haas

According to the Tasmanian Sporting Almanac of 2001, St Marys played its first competitive game of Australian Rules football way back in 1884. Although records are sparse back then, it appears games were played against Fingal and Avoca with the team winning the most games for the year being the ultimate winners. Mathinna also had three teams back in those days, but they, too, must have played each other because there is no record of a Mathinna team joining the Fingal Association until around 1920.

The first record of a Grand Final being played was in 1891 when it was won by Avoca. St Marys, however, didn't win a Premiership until 1924. The Rovers (Cornwall and Mt Nicholas) won their first and only Premiership the next year and

St Marys took the cup back in 1926.

1929 and 1930 were great years for the Tigers, winning their first back to back Premierships. But it was the 1930 Premiership that many old hands rate as the Grand Final of the Century. Not only did St Marys win by 20 points after starting underdogs, but started the biggest melee ever seen.

The 1930s saw hard times in the Fingal Valley as the Great Depression began to bite and the Fingal District Football

Association was forced into recess in 1934-35.

Footy was back in 1936 when the Rovers and Avoca played a draw and when the Rovers refused to replay the game, Avoca was awarded the Premiership.

1939 saw St Marys take the field again against Fingal with a win to St Marys by 15 points. This was the last game before another recess due to World War Two.

Again in 1946 and '47, St Marys won back to back Premierships, but 1948 was to be the beginning of a long drought for the Tigers. Although St Marys played off in 10 Grand Finals in the next 25 years, 8 of which were against Fingal, it wasn't until 1972, under non-playing coach, Dale Wright, that the drought was finally broken.

The drought was short lived; however, it took another 11 years until 1983 when St Marys recruited City South star, Wayne Chugg, as coach and along with a couple of quality imported players to help the locals, the prestigious flag once

again flew in the clubhouse.

Lynden Dakin, the son of John Dakin, who played in the 1972 Premiership side, took on the coaching role 7 years later and once again St Mays was able to repeat their efforts of 1929-30 and 1946-47 by winning back to back premierships in 1990-91. St Marys played off in the final FDFA premiership in 1972, but was defeated by St Helens.

St Marys Reserves had a little more luck than their senior partners. With their 30 odd years of participation in the Fingal District Football Association they won 11 Premierships: 1966 - 1967 - 1968 - 1970 - 1971 - 1972 - 1982 - 1984 - 1987 - 1990 - 1992.

Thirds, or under sixteens, were not quite so lucky they won only 3: 1969 - 1973 - 1986.



FOOTBALL SNIPPETS

According to the Fingal District Football Association records, St Marys forfeited the 1937 Grand Final to Avoca. It seems odd to not play in the most important game of the season. Can anyone tell us why?

St Marys Football Club had a 25 year drought of Premierships from 1947 to 1972. One coach was heard quoting a saying made famous by American Grid Iron coach Murray Weymouth: "If lessons are learnt from defeat; our team is getting a great education."

Fingal District Football Association meeting, held on the 2nd September 1929.

At this meeting E. Rees of St Marys was found guilty of kicking A. J. Margison of the Cornwall-Mr Nicholas Rovers. Mr Rees was stood down for one week. The St Marys delegates, W. Mitchell and G. Bolton, immediately resigned and left the room.

Mr L. Dawson of St Marys was also stood down for one match for disputing the umpire on several occasions.

Extract From Weekly Courier, October 16th 1929

Members of the St Marys Football Club were guests of the Scottsdale Football Association last weekend when they journeyed to the Northeast town to play an Association team. The game was played in good spirits and eventually ended in a draw.

The St Marys team left in two cars on Friday evening and went as far as Derby where the local people had arranged a dance. The party left Derby at 11.00 am on Saturday and soon arrived at Scottsdale, where they were met and welcomed by club officials. The game was even all day and at the final siren the scores were: 10 goals 12 behinds a piece. St Marys players left Scottsdale at 11.00 am on Sunday and travelled via Launceston, arriving in St Marys on Sunday

Extract from Weekly Courier: August 31st 1922

On Saturday a football match was played between the Cornwall-Mt Nicholas Rovers and a combined team from St Marys and Fingal. It was a charity game and a collection amounting to eight pounds five shilling was donated to the blind, deaf and dumb of Tasmania.

The game was strenuous, but exciting and ended in favour of the Rovers. Scores: Rovers, 8 goals 3 behinds to St Marys-Fingal 3goals 5 behinds.



I am writing due to my grave concerns regarding the health of our community in all of the regions of the Break O'Day municipality.

I have witnessed the recent terrible Forestry Tasmania burnoffs that have occurred in the week of the 5th May 2009 from my property which overlooks the coast line from Falmouth through to Flinders Island. I have not been able to see past Beaumaris due to the smoke haze emulating from FT's burnoffs. (see photo right)

My concerns are also about the chemical and respiratory fallout affects from these burnoffs and the health of our aged and frail and also the healthy population of residents who live within the BOD region.

I urge all concerned community members to express their concerns to their local political members explaining their complaints regarding issues that effect themselves and family members.



There are several issues such as the FT burnoffs and general Forestry issues, the use of pesticides including triazines and 1080 use by plantation companies and properties.

The community have to speak up and have a voice and bring these issues forward especially now, the local and state elections are only months away.

It has been noted and documented that the BOD region has a high rate of ill-health and cancer.

We have to ask our local Break O'Day Council what is their position regarding these very important issues and what are they prepared to do to ensure that we all live in an environment that is safe and protects the community from exposure to environmental toxins for all of our community to live in.

How can we promote the region as the premium tourist destination and also the perfect place to retire, when it is affected by such negative and very concerning health issues that we all face on a daily basis.

I know that we have the immediate issue of regeneration burnoffs, however we should have additional concerns regarding the ongoing triazine (Atrazine) effects, such as endocrine and immune system disruption.

There are many issues here with the use of endocrine disruptors (Atrazine), not just our precious water, there are issues of over spray when private companies spray near waterways and near properties that grow our vegetables and produce.

Add to that the use of 1080 that has a onflow effect from "controlling"

the vermin i.e wallabies, possums and wombats who graze on farming properties, is there a connection with the problems with the Tasmanian Devil with the long term use of these insidious chemicals?

The community has to question..."is it worth letting the use of these chemicals for the gain of a handful of companies and their profit margins, to the detriment of our community?" No its not, our communities health is more important than anything else, so lets speak out and have a voice in the upcoming elections.

The Australian Government must adopt the EU principles in their approach to pesticide regulation. The debate on pesticides is as relevant today as it was in the 1970's when DDT was originally banned.

DDT has yet again been banned as the adverse human effects cannot be compensated for in economic terms.

The alarm bells for many of the pesticides currently regulated for use have been ringing loudly for many years adverse changes in immune systems, endocrine systems, cell signalling, epigenesis; the list is extensive.

The Australian Government is choosing to ignore the well found reasons that the EU have for taking a precautionary approach to pesticides, with the removal of the most toxic pesticides and removing aerial spraying.

The chemical companies that sell pesticides have an inordinate influence on political and economic decisions at all levels of government.

Compounding this, especially in Tasmania, the forestry and agriculture industries dominate political and economic decisions which markedly affect population health. This is wrong. Repetition by lobby groups (including APVMA), of a message does not make it correct.

If the current situation continues with the pesticide lobby influencing government health decisions, the ultimate economic cost will be unable to be met and decisions will have to be made regarding rationing health services.

In The Australian, (25/11/2006) Nick Minchin, the then Federal Finance Minister warned of spiralling health costs if the link between toxins in the environment and cancer and chronic illness was ignored. He said a link between toxins and cancer and chronic illnesses was "common sense" and its impact on the health budget "keeps you awake at night".

The investigation should provide Council with a clear understanding of the social, environmental economic, impacts benefits of the proposal, and give broad considerations to maintaining local representation if a voluntary merger was to be undertaken. This process must include extensive community consultation Council reserves the right to withdraw its voluntary consent to the merger if it subsequently determines following investigation that it is not in the best interest of the community."

This motion was carried unanimously.

The motion still stands in its original state, it has not been changed in any form what so ever, how can Clr Johns say we are going where no one has looked, we asked the board to look at the big picture. After Clr Johns voted in favour of the investigation I find it hard to follow his logic in his comments.

After the board has held public consultations throughout both Municipalities and a due diligence exercise into the financial structures and handed down their findings then Clr Johns can reject or accept the findings.

Council is not heading blindly in any sense at all, the motion is very clear and how Clr Johns can publicly misinterpret facts is beyond belief.

The Glamorgan Spring Bay Council at its full Council meeting voted 6/3 to proceed along the similar lines as the Break O'Day Council.

Dear Editor,

I apologise to the Break O'Day community for my lack of judgement in supporting a motion moved at a Special Meeting of Council on 2 February 2009 to request the Minister for Local Government to instruct the Local Government Board to investigate the consequences of amalgamation of the Break O'Day and Glamorgan Spring Bay Councils.

I opposed the motion that the meeting be closed to the public, and was concerned that neither the Notice of Meeting nor the Agenda for the meeting advised the purpose of the meeting, nor included notice of any motion other than "Closed Council Item". I also would not support an initial motion mooted to support the concept of an amalgamation of the two councils, of which some councillors appeared to have pre-knowledge, but not all.

However, after advice to Council by the Mayor, I did support, and indeed seconded, the following motion, which has since been made public so that I am not in breach of my obligation to maintain confidentiality on the matter. I repeat the motion here to put this apology in context, and because it is apparent that most residents are neither aware of the decision, nor aware that it is being activated, nor have any understanding of the issues and potential consequences of this decision:

"The Break O' Day Council request the Minister for Local Government to instruct the Local Government Board to investigate the consequences of a voluntary merger between the Break O'Day and Glamorgan Spring Bay Councils in their entirety as soon as possible. The investigation should provide Council with a clear understanding of the social, economic and environmental impacts and benefits of the proposal and give broad consideration to maintaining local representation if a voluntary merger was to be undertaken. The process must include extensive community consultation and Council reserves the right to withdraw its voluntary consent to the merger if it subsequently determines following the investigations that it is not in the best interests of the community"

In all the circumstances of that meeting, I believed that this decision indicated an open minded approach to an issue that had come to light, albeit only as a result of a newspaper article leaking information about secret discussions being held on the matter, of which I as a Councillor was totally unaware, and that a request for information, with the condition of extensive community consultation, coupled with an escape clause allowing the process to be terminated, was a responsible decision, and I supported the motion. The issue of whether an amalgamation of the two Councils into one Council area stretching from Buckland to Weldborough would benefit residents or not, is not the purpose of this letter- it is that on investigation and questioning I have reached the opinion that the terms of that decision in fact provide no safety net for a voluntary withdrawal by your Council from the process it has started, and that the decision of the future identity of our towns and districts and their ability to be closely involved in their own affairs has been handed over to an outside body and subject to the decision of a Minister. Further, it is now revealed that there are behind the scenes discussions being held of which your elected representatives are not aware to increase even further the extent of amalgamation to include 7 East Coast Councils, as announced by the Mayor of Sorrell on "Stateline" on Friday 15 May.

I believe my part in the above decision was a mistake, and I need to publicly acknowledge this to allow me to direct my energies to ensuring that the intents of the motion, to be objectively informed, to have extensive community consultation, and to be able to withdraw from the process, are indeed honoured, and to the hilt- and to prevent others from attempting to stifle and rebut those efforts by claiming that I supported the decision in the first place. I did then, I don't now because I believe that there are agenda at work far beyond the Break O'Day and that we are the Judas cow in this matter.

Also, while supporting the concept of being informed on the potential consequences of a merger, my present belief is that on balance such an amalgamation would not be in the interests of the people and communities of the Break O'Day, and that I wish to work to oppose such an amalgamation- in this context any offers of support from readers to this end would be readily accepted.



'Youth Violence' topic of Crime Stoppers Youth Challenge 2009.

Crime Stoppers Tasmania today launched the Crime Stoppers Youth Challenge 2009, with a focus on violence against young people.

Housed in The Working for a Safer Tasmania exhibit at AGFEST, the Crime Stoppers Youth Challenge launched into its eighth year of this successful educational program.

The Crime Stoppers Youth Challenge Tasmania is a competition for students in Years 5 to 10.

"The program aims to have students research the impact youth violence potentially has on their own community and suggest initiatives to tackle the issues and reduce related crimes," said Brian Aherne, The Chairman of Crime Stoppers Tasmania.

Participants are encouraged to work together in school groups to design practical solutions to assist in prevention and reduction of youth violence.

Why this topic?

In collaboration with Tasmania Police, the board of Crime Stoppers Tasmania and schools, 'Youth Violence' was chosen as a particularly topical and pertinent theme affecting Tasmanian communities.

The increasing trend of violence among young people is of great concern and has the potential to significantly impact upon the lives of offenders, victims and their families.

Violence can be potentially both physical and psychological. It can occur in a range of social settings but also within the confines of the home.

The growth in new technologies has seen an increase in the ways young people communicate. Email, SMS, and a multitude of social networking sites, like YouTube and FaceBook, have provided new opportunities through which bullying and other forms of violence can be directed.

Crime Stoppers Tasmania invites schools to participate in this year's challenge to assist in identifying and addressing many of the issues linked to youth violence and examining the role that Crime Stoppers can play in tackling these issues.

Three entry categories are:

Upper Primary Years 5/6
Lower Secondary Years 7/8
Upper Secondary Years 9/10

The Crime Stoppers Youth Challenge is designed to help young people:

- * understand the context of crime, ethical issues surrounding crime, the motivations of those committing the crime, and the causes of crime;

Registration closes 12th June, 2009.

Entries close Friday 25th September, 2008. Judging will take place in October with an awards ceremony to be held late October.





At the recent council meeting a motion to overturn a previous motion to record all "questions without notice and answers" was raised by the Mayor. Under the Mayor's motion this will stop. Which I believe will further limit information on the public record, sought by Councillors on behalf of the residents.

The main thrust of the motion was that it provided no benefit to Council and in a number of incidents it would appear that it was used to denigrate the Mayor and the General Manager, no proof of these allegations were submitted in support of the motion.

The Mayor maintains that these matters can be answered with a phone call to the Mayor or the General Manager. This was passed with Cllrs Harper, Johns and Clement voting against.

A further development was the General Manger recommended that Councillors motions be approved prior to them being presented for discussion and decision. This is to cut down on staff time writing reports on motions that may or may not be passed.

I think that this will impede the process of decisions making as it will now require two months for a motion to be acted on.

Three Councillors raised concerns and voted against the acceptance of the Business and Corporate Services report as they believed that it did not contain enough information on the overall financial position of the municipality and was only a simplified statement of income.

Cllr Clement proposed a new and fairer rating system for dog registration fees. Council voted to accept these revised fees.

Council passed a remission of Building and Planning fees for a fire affected family in Scamander. This is a show of real compassion on behalf of the Councillors.

Other remissions passed were:-

Boat shed in Anson's Bay

The Falmouth Community Centre had its belated tennis court grant application approved.

The name Winifred Drive was assigned to the road leading into the new subdivision at the eastern side of the Tasman Hwy in Scamander.

In the Cyclopaedia of Tasmania (1900-1902) it is reported that Frederick Napier JP, the owner of the oldest general store in St Marys, was born in Hobart in 1868. He was educated at the City School under Principal Mr H. M. Pike.

After leaving school he entered into business pursuits with his father, who purchased the store at St Marys some fifteen years ago. When his father died in 1892, Frederick took over the store and established himself as a fine community man, having an active interest in public matters which included being a councillor for the Fingal Municipal Council, as well as a Justice of the Peace. In 1899 he married Miss Hogarth, daughter of noted Ayrshire cattle breeder, Thomas Hogarth, of "Glenburn" Sulphur Creek.

The general store, which was originally founded by Mr. W. Lade in the 1860s, not only commanded the trade of the immediate neighbourhood, but of the coalmines and the entire surrounding country.

An important feature of the business was the purchase of local dairy produce for export to principal markets. The stock was varied and extensive; in fact, was full of every class of goods suitable for the requirements of the district.

(The original Lade-Napier general store was on the corner of Groom and Cameron Streets)


All of the above have braved the hostile elements at times to contribute to our club's funds and soon we will see the fruits of their labour.

HUMAN SWINE FLU FACTS

Media release from Director of Public Health.

As of this column going to print there are no registered cases of human swine flu in Tasmania, but Tasmanians should not become complacent about ringing the hotline and taking precautions.

The World Health Organisation remains at Pandemic Alert Phase 5 in the global response to swine flu—meaning we need to finalise our organisation, communication and planning measures for a possible pandemic.

The Tasmanian Government has been working hard to achieve this and we reiterate calls to all businesses and organisations across Tasmania to do the same and ensure they are well prepared.

It remains important that recent travellers continue to heed the public health messages which are;

If you have been in Mexico, the United States or Canada recently, or been in contact with someone who has Human Swine Flu AND you develop signs of flu – particularly fever AND cough, sore throat or nasal congestion (blocked or runny nose) – please phone 1800 FLU DOC (1800 358 362) straight away.

At this stage the virus is affecting young to middle age healthy adults most.

In Tasmania, any cases reported will be closely monitored and authorities are liaising with their interstate counterparts to ensure the state is prepared, just in case.

The call centre has been established to provide information to the public (call 1800 FLU DOC or 1800 358 362). Resources to help everyone to reduce the risk of catching the flu are being circulated to health professionals and stakeholders and are available on www.pandemic.tas.gov.au.

This website is being updated regularly, and additional communication resources are being developed.

The Department of Health and Human Services has activated its emergency arrangements to oversee the health response and a state crisis centre has also been placed on stand-by.

Signage giving advice to incoming travellers is in place at airports and ports across the state.

Information is being provided regularly to hospitals, GPs and other health centres, asking staff to be on alert for any possible cases of Human Swine Flu.

Local councils have been instructed to develop plans for Flu Clinics.

What we want you to do


- 1. The Director of Public Health has urged anyone advised to remain isolated in their home, to strictly follow that advice. It is extremely important that anyone being investigated follows the instructions given to them by health authorities.
- 2. Ring 1800 358 362 (1800 FLU DOC) straight away if you have been in affected countries in the last seven days and develop flu symptoms.
- 3. Learn the symptoms of influenza

Influenza generally comes on suddenly and causes fever, dry cough and fatigue. It can also cause sore throat, muscle aches and pains.

4. Protect yourself from seasonal influenza.

Get vaccinated against seasonal flu. It won't protect you from Human Swine Flu but it will:

- o minimise confusion between seasonal influenza and Swine Influenza
- o protect you and anyone you come into contact with from the three worst strains of seasonal influenza
- o help to reduce the load on our health services.
- 5. Wash your hands thoroughly with soap and warm water (or alcohol-based rub) before touching your mouth, nose, eyes or anything that goes in your mouth.
- 6. Cover coughs and sneezes, with a tissue or even your arm if you don't have a tissue available.



Water and sewerage concessions

The Treasurer, Michael Aird, announced last week that the draft policy on the new concessions framework for the water and sewerage sector was now publicly available.



Mr Aird said the Government committed to introducing new concessions legislation as part of the water and sewerage reforms to provide guaranteed support to low income customers.

"Under the draft Community Service Obligation (CSO) legislation, the new concession for water and sewerage services will be a minimum of \$130 per eligible customer per household.

"This is higher than the amount of the implied concession received under the existing Pensioner Rate Remissions Scheme and will increase over time under an indexation arrangement.

"The eligibility criteria are the same as for electricity and include the holders of a Health Care Card or Pensioner Concession Card and those who hold a Department of Veterans' Affairs Repatriation Gold Card.

"Under these criteria, approximately 73,500 customers will be eligible for the concession.

"This means thousands of new customers will now be eligible for a concession for water and sewerage.

"The concession will be administered by the water and sewerage Corporations, which are also required to develop a hardship policy to assist disadvantaged customers.

"It is appropriate that Councils, who receive a return from their ownership in the water and sewerage assets, fund the concession.

"This is the same model used for State Government funding of electricity concessions through its ownership of the electricity businesses.

"The State Government will continue to support the Pensioner Rate Remissions Scheme in relation to those services that remain with councils."

Subject to the public consultation and parliamentary approval, the legislation is expected to come into effect on 1 July 2009.

Rent holiday for pensioners

The Minister for Human Services, Lin Thorp, has reaffirmed that the State Government would not be seeking to increase the rent of aged pensioners with Housing Tasmania when increases arrived in September.



Ms Thorp said the State Government welcomed the boost to single and couple aged pensions and have made sure the full benefit of the pension increase is protected by implementing a rent holiday for this increase.

"This Government recognises that pensioners have been doing it tough for a very long time and this decision will assist them to live a little easier," Ms Thorp said.

"I've spoken with the Premier about this matter and we are agreed that this is the reasonable thing to do. We're determined that pensioners will receive the full benefit of the increase when it arrives.

"We're very aware of the difficulties many pensioners face in attempting to make ends meet and this decision to grant a rent holiday is a contribution to making that task a little easier.

The Rudd Government budget measure will take effect from 20 September 2009, and deliver a boost of up to \$32.49 a week to single pension recipients on the full rate.

Housing Tasmania would normally apply a rent calculation based on increases pensioners receive to their income. This most often occurs when Centrelink passes on a quarterly basis.

Technology removing barriers for rural patients

Innovative technology is helping break down the barriers of distance and isolation for patients living in rural and regional Tasmania.

Health Minister Lara Giddings visited Agfest last week to view the display of technology being trialled or investigated by the Department of Health and Human Services in partnership with Telstra.

Ms Giddings said there was no better place to showcase the technology than at Agfest, where thousands of visitors would be interested in learning how their healthcare experience could be made easier.

"The DHHS Telehealth team is looking at a wide range of technologies to connect communities with health professionals located many kilometres away," Ms Giddings said. "This technology is breaking down the barriers of isolation and distance.

"It is also about reducing the need for people living outside of Tasmania's main cities to travel for specialist services.

"This type of innovation is a perfect example of the future for health care envisaged in Tasmania's Health Plan,"

Ms Giddings said.

Two telehealth technologies were showcased at Agfest – the Mobile Phone Telehealth Solution and the 'In the home Telecare Solution.

Ms Giddings said that ground-breaking mobile phone technology will be trialled in the Central Highlands and Derwent Valley.

"This involves using mobile phones for video conferencing during home visits by community nurses.

"The nurses visually link up with other members of the client's health care team - as many as six additional health professionals can be involved in the conference from anywhere around the State.

"All the health professionals can see and speak with each other as if the whole team is actually in the client's home. This saves both the patient and members of the health care team from unnecessary travel. The home consultation is bolstered by a DHHS vehicle fitted out with additional Next G and WiFi aerials, as well as a Next G router.

"This brings the added benefit of boosting broadband connectivity for Tasmanians living in rural and remote areas."

Ms Giddings said another exciting development is a unit which can be installed in a client's home to collect and transmit important health data.

"The information collected ranges from weight, temperature to blood glucose levels and it can be transmitted back to a GP or nurse in another location.

"If vital signs are not what they should be an alert is triggered and health professionals know it is time to make contact with the patient. This technology is exciting because it gives the patient a chance to have more power over the management of their own health," Ms Giddings said.

Ms Giddings said the recent expansion and upgrade of the Tasmanian Telehealth Outreach Network - from 40 video conference points to 120 - would also boost health services to rural and isolated areas.

"The Telehealth links are located in the major public hospitals, rural hospitals and community health centres around Tasmania," Ms Giddings said.

Other examples of how DHHS staff are using these technologies to eliminate geographical challenges associated with service delivery include;

Specialist advice: Health professionals in rural and remote communities can now use the Telehealth Network to consult with specialist and emergency staff located in major hospitals when faced with health situations that require additional expertise. Remote visual assessments of clients can be made to ensure all possible expertise is engaged in the treatment.

Professional development: Health service professionals located in rural and remote areas now have the opportunity to continue their professional development using the Network, keeping up to date with the latest treatment practices. While developed specifically to increase access to a wider range of health services for Tasmanians living in rural and remote parts, the Telehealth Network is also available for use by not-for-profit organisations as a community service.



Is anyone getting concerned about the impending changes to water and sewerage provisions in the next couple of months? What worries me is there hasn't really been a lot of detailed information as yet passed on to us, the ones who will be directly affected by it all. By now I imagined that a public awareness campaign would have been prominent in the media to begin telling us what the story is. Unless I have missed something, this doesn't yet seem to be the case.

One thing is pretty well assured though. It will be more expensive in the initial years to begin recouping various costs in the changes. I'd like to think that in five years we will be saying how much better off we are than now but to coin a phrase "A lot of water will pass under the bridge" before this may be the case.

I'd just like to know what we are in for particularly financially and what improvements are to be provided to us as time goes by. Let's fervently hope that we do indeed get a better water and sewerage service and not just finish up paying more for what we already have. Let's make this change genuinely worthwhile and informative soon.

Some really good recent news comes from the school on several fronts. Only a week or two back the St Marys District High School was officially recognised as the Most Improved District High in the state and, as it happens, by a substantial margin. This is great news and is backed up by the true pride that is fostered in wide and varied academic, performing, and sporting achievements recently.

I'll give you some examples. Since returning home, the Arts On Tour crew have been widely recognised for their exceptional efforts whilst traveling in the South, as we touched on before. Since then though, the school senior science students took part in the Australian Brain Bee Challenge in Neuroscience. Some truly wonderful news is that 7 kids took on the demanding exam and all 7 progressed to the next round, by achieving results twice the National benchmark. This is a fantastic, almost unheard of achievement from a school competing for the first time in this prestigious competition.

They were also up against 9000 other students and have two teams competing in the State Final in Hobart on June 18 in the Teams Event, while all 7 are up for individual honours as well. There are major prizes for both school and individuals including a place in the National Final in Sydney and even an international trip too. Given some of our kids scores were in the top 10 in round one they have optimistic hopes for good results here. Their teachers and advisers are a big part of all this and it all topped off an amazing couple of weeks academically.

On the sporting front there have also been some high achievers with a couple of the current students achieving selection in representative football teams along with some quite recently left students doing the same. These players should be genuinely proud of this at such young ages and no doubt all of us are.

In the next few months there are some incredible opportunities for the kids to show their skills and added to this is the major improvements in the wind for infrastructure on the education front. Like never before the local students of all ages have a lot to get excited about.
