## St Marys Main Street Makeover Community Meeting

To be held Wednesday 8 October, 7.30pm, St Marys Memorial Hall

Residents of the St Marys district are invited to a public meeting **next Wednesday week**, to consider plans for the development of the St Marys streetscape, developed by the Makeover Committee. The purpose of the meeting is to obtain community reaction to the plans, and to allow responses and comments to be taken into account by the committee before submission of the plans to the Break O'Day Council at its meeting on 13 October

The original concept plans were discussed at public meetings in late 2007, and a committee of 12 local residents formed at the meeting in January 2008 to develop a final plan. The committee has established and worked through all the options presented at the earlier meetings, and brought before it since.

Discussions have been held with the Council Works Department and with the Department of Infrastructure and Energy.. Residents and businesses fronting the streets included in the project, attended the last meeting of the committee to express their views, and the proposed road alignments were road tested by a big local heavy vehicle (and driver)! As observed by Bob Oates (Voice 14 September), there has been "endless meetings in the street with much arm waving and heated discussions"!

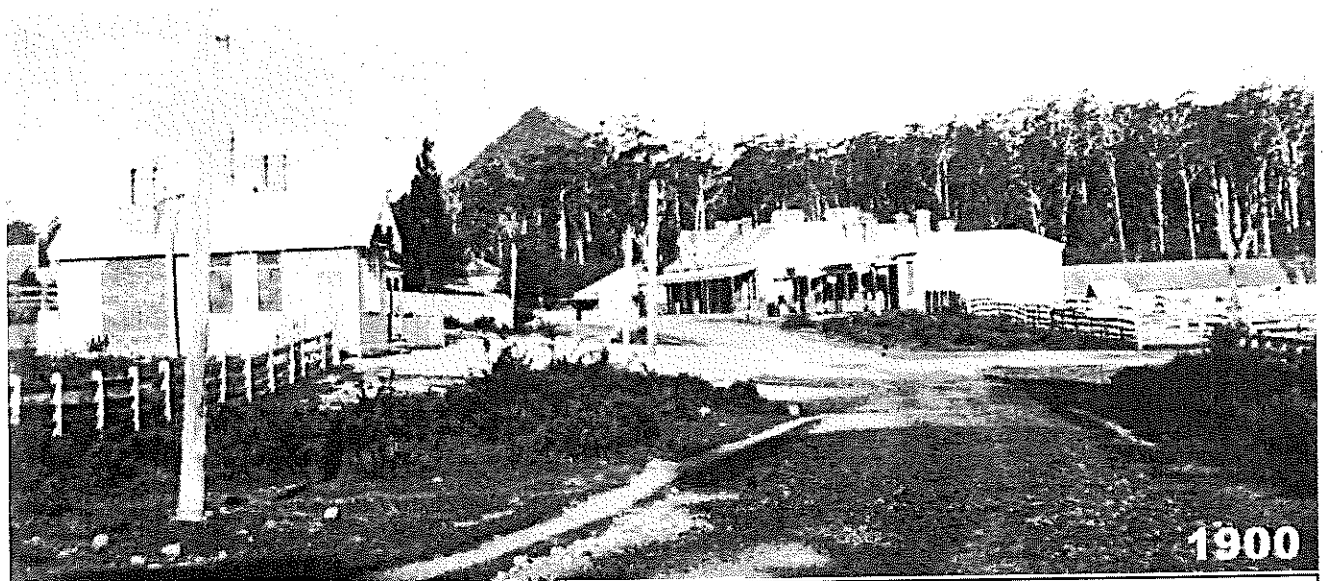
The 'Main Street', for the purpose of the project, has been defined as from 'The Flat' bridge from the east to the end of the kerb and guttering to the west towards Fingal, and Story Street from the pub corner to the intersection with Groom Street.

A major issue has been the need to ensure adequate and safe parking in the town for the future, as this is fundamental to the amenity of residents and the enhancement of the visitor experience, the two main criterion for the grant of \$150,000 from the State Government.

As part of the overall plan, two proposals will be submitted to the meeting, one on the basis of retaining angler parking, but with extra safety space for reversing, and the other based on parallel parking and a wider footpath between the TARDIS and the Cameron Street footpath.

This is your town. Your judgment of the plan and your input is critical. The committee has worked hard to develop a plan that will achieve as much as possible with the available money over the next 6 months, as the first stage of a longer term plan for enhancing the sense of place that is particularly St Marys with the theme of "Share Our Town".

See you there, 7.30 start, next Wednesday week, at the Hall.

## A LITTLE BIT OF HERITAGE: Jim Haas

### "Our Council"

Was the amalgamation of the Fingal and Portland Councils a good thing or a bad thing? This is a question many ratepayers in the Fingal Valley often ponder. But did you know that the original Fingal Municipal Council formed in 1863 did, in fact, include Georges Bay? (St Helens)

The first election, held on the 27<sup>th</sup> February of that year, saw twelve candidates stand, six of whom were elected. They were: Francis Groom of Harefield, Thomas Ransom of Killymoon, James Grant Junior of Tullochgoram, Robert Clark of Malahide, Charles Parker of Benham and Robert Stuart of Fingal. Stuart, who was the Assistant Police Magistrate for the district at the time, was elected Warden.

The start of Government decentralization in Tasmania began during the term of Lieutenant Governor George Arthur, (1824 to 1836) when police districts were set up under the control of magistrates. At that time the Fingal Valley came under the jurisdiction of Campbell Town. In 1837 a sub-district was created and an Assistant Police Commissioner stationed at Avoca. The administration was moved to Fingal in 1842 and housed in the Probation Station.

The next move by the Government was the creation of Road Trusts in the 1840s which led to the Rural Municipalities Act authorising the formation of municipal councils in 1858. To form a local council each district had to come up with a petition signed by at least 50 land owners, whose qualifications were based on the value of the property they owned. Although a few districts moved rather quickly to form their council, there was quite a bit of opposition to the concept in the Fingal Valley. The first petition taken up in 1861 was rejected, and it took another year of lobbying by the pro council group before a second petition was able to convince the Government that the people of the Fingal Valley were ready for their own council.

Nineteen municipalities were formed between 1860 and 1866, one of which was the Rural Municipality of Fingal, with its boundaries based on the old police district of Fingal, which reached from west of Avoca through to St Helens on the coast. All councils subsequently elected took on the responsibilities of police services, water supplies, public roads, registration of dogs, impounding stray animals and licensing of butchers etc.

The Probation Station at Fingal was the initial home of the new council until Launceston architect, Henry Conway, was employed in 1878 to draw up plans for a Town Hall at Fingal. But it wasn't until October 1882 that the foundation stone was laid by the then Warden, J. H. Grueber.

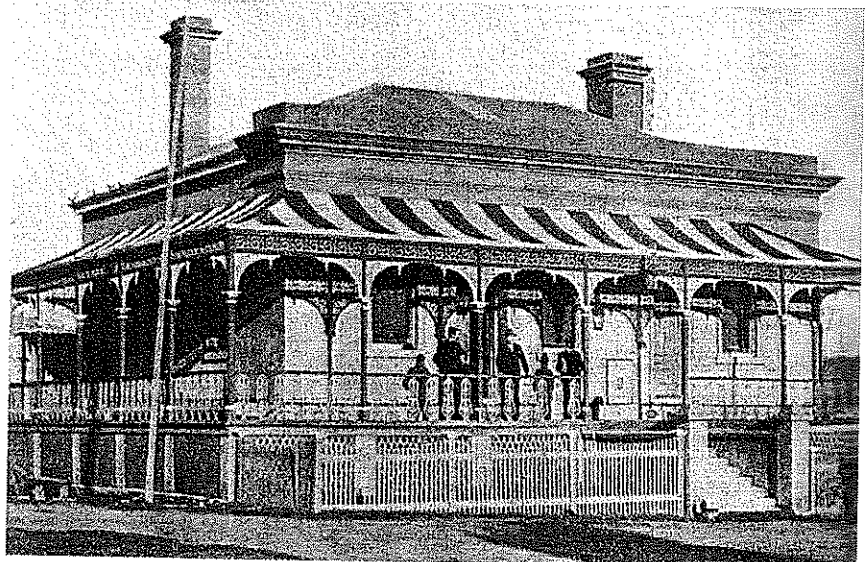
The new Town Hall was said to be a fine building and served the Municipality well until it was destroyed by fire in the early part of the Twentieth Century. This unfortunately led to all records being lost, and with newspapers covering very little on Local Government matters in those days, not a lot is known about our early Council's affairs.

One major development that did make the papers, however, was the drawing up of new boundaries in 1877, which saw the Fingal Municipality end at Scamander River, resulting in the loss of the Municipality of Georges Bay (St Helens).

The Fingal Council was extremely irate about the change, and the Warden wrote to the Colonial Secretary informing him that the Council's legal advice stated the boundary change was illegal. He said under no circumstances would his Council give up the Grant Deed of the municipal land at Georges Bay. But the Colonial Secretary had the ruling hand, the new boundaries were enforced, and no compensation was paid to the Fingal Council for their loss of what was later to become part of the Portland Municipality.

A new Council Chambers was built at Fingal immediately following the fire in the early 1900s. This building still stands proudly today, but not as Council offices. A new state of the art structure was built opposite the old Tasmanian Hotel in Talbot Street only a few short years before the 1993 merger of the Fingal and Portland Councils to form the current Break O'Day Council, the headquarters of which was soon established at St Helens.

The Fingal Valley people thought they were short changed back in 1877 when they lost the Municipality of Georges Bay. Today, with the loss of the headquarters and administration to St Helens under the Break O'Day regime, one wonders if the Valley hasn't been short changed yet again.

Dear Editor.

I would like to clarify some points in regards to the designs/setbacks of the Surf Life Saving Club and subsequent Skatepark, and believe the rate payers have been grossly mis-informed in previous articles.

The new design is 362m<sup>2</sup>. The design submitted with the second DA is 340m<sup>2</sup>. I believe this is around 6% difference.

The original design is double storey, long and skinny and site specific. With the new location and large site area this double storey design impedes the visual sighting of the foreshore from neighbouring properties. On-site discussions were had with the General Manager, council staff and representatives. A preliminary split level design and site plan was discussed and agreed upon. The site plan showed the setback as 10m from the skatepark. Council agreed to pay for the new design and have done so. The new design is split level with a height reduction to allow neighbouring properties minimum visual intrusion.

The skatepark position is not as the site plan discussed that day and has a reduction of approximately 1.5m thus reducing the setback to the proposed surfclub to 8.5m. This setback is to only part of the surfclub with the storage section setback 11.8m.

The setback from the skatepark to the carpark is 8.5m. What is the bigger safety risk, a skateboard hitting a car, occupants or a solid building.

I am well informed on these matters as I produced the Development Application, skatepark drawings and detail as with site plans for the skatepark to be a success and have been involved all the way with the Proposal for the Surfclub. I have all the drawings and detail to back this up and you are hearing it from the Horses Mouth (so to speak) not hearsay.

I surely hope both these projects are successful and will become an asset to the community and more importantly bring the community together. I also envisage this foreshore area to become the hub for social and recreational activities for residents and visitors alike and promote the beauty and lifestyle that we all relish.

Letter to the Editor: Cancer & The "RIFE" Machine.

I don't purport to know exactly what they have done with it all but I do know firsthand all about research and the cost of same. Now just to put everyone in the picture, without research on any subject matter we would not be where we are today, i.e. we would not have penicillin, we would still be having plagues, there would be no life saving surgery to the degree it is done today, we would have no frozen, tinned, packaged foods or dehydrated foods (for our armed services or explorers etc), no electricity, aeroplanes or cars, as a matter of fact everything in life comes from some sort of research or another.

That means research, research and research again, until they get it right and that means the investment of money and time to allow those processes to happen. What better research than trying to find not only cures but preventatives for an insidious disease like cancer, especially in our children.

I also want to thank Charles for giving me a disk so I could see for myself the history of the Rife. With the Rife Machine, if Mr Trollope believes it worked for him, so be it, and I applaud him for being a survivor.

That does not give him the right to denigrate the Cancer Society in the manner with which he has done. 22 years ago I had ground breaking surgery and treatment for an advanced cancer, my work colleague was diagnosed with an identical cancer at the same time. I was as Charles so eloquently put it "cut, burned and poisoned", my colleague had surgery but no other treatment - I am still alive today, sadly she died 18 months later.

My sister was diagnosed with aggressive cancer throughout her body, stopping just shy of the brain and given 3 months to live. She had emergency surgery as an unknown quantity, followed by massive chemotherapy but, she also had God on her side and in her heart. After stopping chemo treatment (her own call) 6 months ago, she is still with us today, she believed that God would either heal her or it was meant to be. What I am getting at is that the power of the mind can also play a big part in the healing process, along with conventional medicine.

People diagnosed with terminal illnesses will grasp at or try anything. Wouldn't you? Just don't deny effective treatments at the same time because someone says "this machine will cure you", the medical profession is around for a reason, not only to give people jobs, they go into the industry to do some good throughout their life and help others, this is enabled only by continuous research.

"Without Prejudice"

Bob Oates' (Voice 14 Sept "Do We Have An Image Problem") remarks about the hawthorn hedges which frame the approaches to St Marys contrast with his previous delight in the sense of place of St Marys as "Heaven".

Bob wants to change the hawthorn lined approaches to Heaven by "giving the place a civilized and tidy entrance", to be achieved by "a bloody great John Deere with a flail mower on a long arm". St Peter on a tractor could be the town logo.

An alternative point of view may be an appreciation of the beauty of the hawthorns through the seasons, the billowing white blossom and spring green of the new leaves, the changing autumn colours, the scarlet berries and stark outlines of the winter branches, a recognition of a living and enduring heritage from early colonial days, providing habitat, shelter and protection for birds and a natural roadside landscape.

Such rampant countryside exuberance, characterised by Bob as "a scary monster type experience", is a refreshing welcome, at least to this resident, as we return home along the Valley, and seems to be regarded as a real attraction by tourists.

And if he wants a more civilized and tidy look, why not learn how to layer the hedges in the traditional way to make them stock proof, establish a Valley Hedging Society, and put us on the map by organising the Tasmanian State Hedging Championship.

If we must manicure our hedgescape to accommodate some suburban ethos, let us at least do it in an imaginative, creative and innovative way, not just flail it physically and in the Voice.

Bob's comments also raise the issue of the progressive encirclement of our town by plantations, a "tidy" monoculture swiftly changing the landscapes which are such an integral part of the St Marys scene.

Hawthorns are not the scary monsters, Bob, it is the ever increasing number of plantations surrounding St Marys that are the scary monsters, they are what will give us "an image problem", drive away tourism, stop new settlement, dry up the water supplies, and destroy this town, plantations artificially fed by tax breaks, and justified by social impact studies claiming that they are beneficial to the 'regional' economy - but not to the local economy, where the trees are actually planted.

Evercrech is a good example, trees in, dairy out, jobs gone, and isn't the plantation at the Falmouth turnoff "civilized and tidy"?

### Letter to the Editor

I write with regard to the letter published in the Valley Voice on the 28 August 2008 written by Mrs Rachel Tonkinson relating to the Council appointment of the General Manager.

I have read with great concern the contents of the letter and especially the request for the Mayor and Councillors to reply via the Valley Voice. It is accepted that councillors will be in receipt of confidential information that may or may not be part of a formal Council meeting. It is **MY** responsibility to ensure that such information is treated confidentially, so as not to harm, prejudice or compromise the interests of Council or any individual or organisation, or enable any individual or organisation to gain a financial advantage.

Council operates in an environment of public accountability in which it seeks to inform the public of issues under consideration and the nature of decisions made by Council. At the same time, Council is conscious of the need to handle Council information in a way that promotes and maintains trust and confidence in the integrity of the local government.

Whilst endeavouring in the interest of public accountability to limit the number of matters which are considered in confidential sessions, Council acknowledges that it is appropriate to consider certain matters in closed meetings.

These included (but are not limited to):

- Information of a personal nature or about personal affairs, for example the personal details of councillors and Council staff;
- The appointment, dismissal or discipline of employees;

Therefore, in accordance with Council policy and good ethical behavior, I will not comment on items that fall within the above areas, but will make the following facts that are specific to letter in question.

- A personal response was drafted and forwarded to Mrs Tonkinson within two (2) days of her letter being published providing relevant responses to her queries.
- The letter, although addressed to the "address as provided, was returned, "UNKNOWN AT THIS ADDRESS".

Research then demonstrated:

- A white pages inquiry provided no contact number for the details provided
- Mrs Tonkinson is not a ratepayer of the Wodonga Council
- The "return address as provided" belongs to a family that has been in residence for the last 11 years (name is not Tonkinson, nor a derivative of same)
- Mrs Tonkinson advised in the letter that she is receiving the Valley Voice by mail, she states that she is informed by the contents of the Valley Voice – I question how can she receive the Valley Voice by mail if the postal address provided is incorrect?
- Mrs Tonkinson states that her son has been waiting for the General Managers position to be advertised – although I question "why" he expected the position to become vacant or other issues this raises; I was subsequently surprised that Council did not receive an application for the job of Business and Corporate Services Manager that was recently advertised.

In my personal opinion, there are too many unanswered questions relating to this letter, and I can assure the community that all efforts to address the contents and concerns were undertaken, however, there are too many areas that demonstrate that perhaps the authenticity of the letter should be questioned.

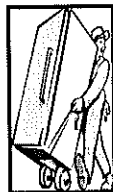
Whether the matter is pursued further will depend on legal advice.

Thank you Councillor Johns for responding to my Letter to the Editor of August 28, as one of the two of our nine Councillors who voted against DA 153-08.

Councillor Johns:

#### Point 1

What condition/s required by Council were not met by the Applicant? Would you identify the specific condition/s not met by the Applicant?

#### Point 2

All DA's are subject to the BODC Planning Scheme 1993, which includes the design of any structure, there can be no prior approvals.

#### Points 3 & 4

It is common knowledge that there was a site meeting held and in attendance were interested parties of the ECSLC, Onshore Designs and the General Manager BODC. This site meeting was as a result of the re-location of an adjoining development which necessitated the change in design of the proposed structure. The ECSLC had no choice but to submit a new design.

A decision was made at the site meeting to re-design a more suitable structure on the new site and also that Break O'Day Council would pay for the re-design. This design has been completed, the BODC invoiced and the invoice paid. I WOULD SUGGEST COUNCILLOR, THAT COUNCIL DID KNOW OF THE NEW DESIGN. The new design conforms with the BODC Planning Scheme and as such was recommended for approval.

If you check the plans submitted to Council they show a much greater clearance distance than the 3 metres you stated.

If you had any doubts relating to safety, you had the opportunity to raise these at the Council meeting and suggest additional Conditions be applied. The Minutes do not indicate that you took this opportunity.

If an appeal is lodged, this is a separate issue and will be dealt with by the appropriate body.

Councillor, it would appear that I am again asking the same question. Why did you vote against the recommendation for approval of DA153.08? Please respond to this specific DA and the criteria of the BODC Planning Scheme only.

It appears that you often vote against DA's which are recommended for approval, compliant or not. A quick check of past Minutes confirms this is a practice of yours.

Thank you Councillor Clement for responding to my Letter to the Editor of 28 August, as one of the two of our nine Councillors who voted against DA 153-08.

Regrettably, you have chosen to introduce personal opinion and conclusions in your response. Therefore I would like to clarify a few items.

Councillor Clement, **do not** attempt to suggest that you can anticipate my opinion or position on other issues, none of which were referred to in the original letter, which you have chosen to introduce in your reply. Is this a defence mechanism introduced by you trying to distract the reader?

Something I will clearly state is that I am neither an advocate for denial of public access to public information, nor am I a cat, fit to "purr".

Likewise I do not wish to be drawn into debate by reference to another application. Each Application must be dealt with individually on its own merits relative to the BODC Planning Scheme. The purpose of this correspondence is to address DA153-08 and your reasons for voting in the negative.

Why did you vote in the negative to DA153-08?

I await what will no doubt be a detailed response.

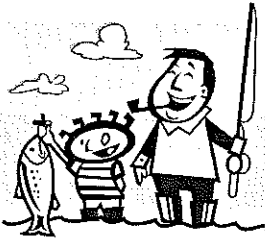

## **VOLUNTEER GRANTS PROGRAM EXPANDED TO HELP WITH FUEL COSTS**

Community organisations across Lyons can now apply for a share in the Australian Government's \$21 Million Volunteer Grants Program 2008.

Dick Adams, Federal Member for Lyons, welcomed the opening of the expanded funding round, announced by Jenny Macklin, Minister for Families, Housing, Community Services and Indigenous Affairs.

## BOOK LAUNCH FOR LOCAL POET

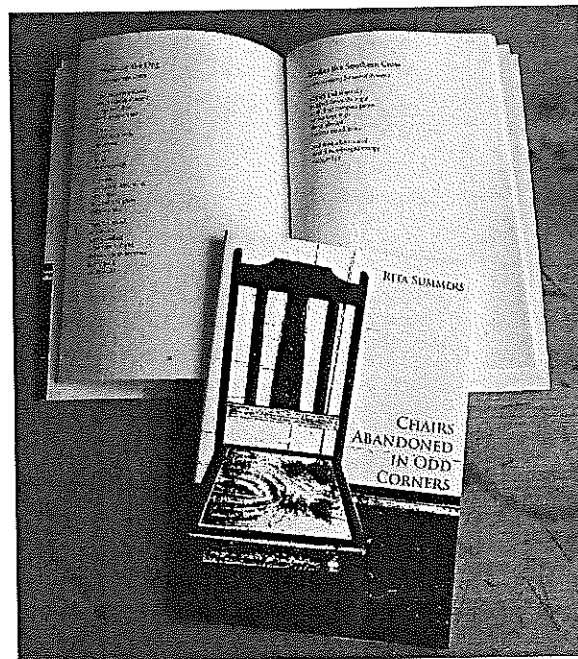
Love ... anger ... joy ... pain ... these emotions and more are expressed with clarity and honesty in the poetry of Canadian-born poet and local resident Rita Summers.

Stephen Matthews (editor, Ginninderra Press, Adelaide, S.A.) has recently accepted and produced a collection of Rita's poems and photographs in a book entitled Chairs Abandoned in Odd Corners. The book will be launched at a readings night (organised by the editor) at *Hobart Bookshop* from 5.30 p.m. on Thursday, 9<sup>th</sup> October. Many of the poems in the collection have previously featured in anthologies, literary journals and ezines, as well as in two earlier small editions of her work published in the USA. Some new, unpublished writing is also included.

Although much of Rita's writing comes out of her own experiences, there is also a deep empathy with the human condition and its capacity for grief and happiness, disappointment and fulfilment, frustration and triumph ... these poems express with a minimum of words a heartfelt response to life and breath in a world that is not always kind but which is often exhilarating. As a result, this collection cannot help but resonate with anyone who reads it.

This first major collection of Rita's work represents a cross-section of poems written at different periods in her life. The photographs which illustrate the book, taken by the poet around her home in Tasmania, are an attempt to express the isolation often felt by individuals who are deeply sensitive to their surroundings and who seek answers to the often unexplainable events which threaten to overwhelm them. The poems themselves, like prayers, speak, whisper, shout or scream in response to different situations. Perhaps the answers can only come as a result of the recognition (and admission) that these situations do exist and that explanations are not easy (or at times even impossible) to find. Ultimately, the expression of them brings release, closure and – finally – freedom.

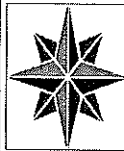

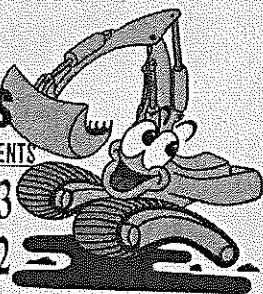

## **DOING THE ROUNDS**

On the 1st July 2009 the State Government will take over the water and sewerage from all 29 Councils in Tasmania. This includes all equipment, infrastructure, staff and outstanding water and sewerage loans, which the Councils own.

The Councils will then become shareholders in the venture. If the venture is successful then a dividend will be paid to each shareholder.

This process has been ongoing for some time. The underlying reason for the State's taking over of the water and sewerage is to eliminate the "boiled water" alerts and provide a universal standard across the State.

However, I believe that while the gesture is right, the procedure has been rushed, and Councillors have been given little time to digest debate and decide on the issue.

There remains today a list of issues that are still unresolved such as:-

- Emergency management
- Planning referrals
- Water re-use responsibility
- Plumbing inspections
- Cost of water etc

Until these issues are resolved and conveyed to the general public I remain unconvinced of this take over.

The constitution for the water and sewerage reform was given to Council and a special meeting called on the 25 August 2008. Councillors voted to have the Objectives of this constitution include the phrase "must be of a quality meeting the requirements of the Public Health Act 1997."

**The original objectives were only concerned with delivery and supply of water and to make a profit with no regard to quality.**

The Mayor moved a motion to rescind this at the September Council meeting and again commonsense prevailed and the motion was lost.

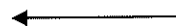

## Death of a Town

Settlements in the north west have been destroyed by being surrounded by plantations. St Marys now faces the same fate, it may take longer, but the pattern has been set, and the recently advertised Denny plantation at Gray continues that pattern. And the destruction of this town will come about because of the complicity of the Break O'Day Council.

The issue is simple-plantations in the wrong place have the capacity to cause harm, harm to the local economy, the local environment and the local community. A plantation (1200 trees per ha) in the wrong place can dry up water supplies, surround houses and settlements, generate truck movements on local roads (at the rate of 14 per hectare planted), eliminate traditional landscapes, skylines, hillsides and sea views, adversely affect tourism, reduce local employment, drive out residents, deter new settlement, degrade the soil, and destroy wildlife habitat and its connectivity.

A combination of plantations in the wrong place can have a **cumulative and aggregate** impact that is greater than the total impacts of the individual plantations- and that is the situation at St Marys. The town is being encircled by plantations, as land owners take the easy dollars offered by commercial timber companies, financed by taxpayer funded Managed Investment Schemes providing 100% write offs of investments in "woodlots". The map will indicate which properties are being targeted-privately owned, already cleared land, containing creeks or springs, and with access to a main road. St Marys is being surrounded by plantations, feeding off the streams, creeks, springs and aquifers of the St Marys water catchment.

Start at the railway station and drive west to Fingal and within a kilometre or so, to the right, is the first plantation, on Bryar Wah, and next door, opposite the entrance to Cullenswood and reaching to Cornwall is the one planted on Beckers. From the hill at Cornwall, look across the valley to the vast plantations on Cullenswood, then back towards the Elephant where the Harefield plantations stretch out and join those on Cullenswood.

Now the Denny property at Gray at the back of Harefield has just been advertised to be converted to plantation. Drive up to the Elephant Pass, go past the Pancake Parlour and turn left up Elephant Farm road to see the plantation there.

Go back to the town and towards St Marys Pass, and drive along Irishtown Road, to the plantation that the Forest Practices Tribunal stated, on the basis of expert evidence, will dry up Margison's Creek. Look at an aerial photograph of the town, and see how the Irishtown Rd plantation is the other side of the hill behind the High School, which faces the golf course. Next to the golf course is Brooklyn, which was advertised to go under plantation until a local landowner stepped in to buy it and maintain it for traditional farming use.

Negotiations have also taken place in respect of 3 other properties adjacent to Brooklyn and Bryar Wah, properties targeted for their cleared land, access to water and to the main road. St Marys will become a cluster of houses in the middle of a sea of plantations, property values will fall, school numbers decline, tourists won't stop, businesses will close, people will move out, the water will dry up, until the Break O'Day Plains becomes nothing more than a woodlot on an investment prospectus for mainland investors and a tradable commodity in the carbon offset market. Ask not for whom the bell tolls, it tolls for thee.

How are Forest Enterprises Australia, Great Southern Plantations and Gunns getting away with this massive change in land use on the Break O'Day Plains and surrounding area. Because the Council Planning Scheme allows it to happen, and because the Council has refused to alter it to require a plantation to be subject to a planning permit to be assessed for adverse impacts on water, settlement, roads, landscapes, or tourism.

Firstly, the land surrounding St Marys is zoned Natural Resources Zone, which makes it very difficult for people owning land to build a home, plant an orchard,

develop a veggie patch, run some chooks or a cow and bring up their family using the natural resources of the land, what used to be called 'living off the land', even on titles that have existed for more than 100 years and have a long history of people living there, at places like Irishtown, Germantown, Gray, and Gardiners Creek Road. In 1857, there were 54 tenancies on Cullenswood, Harefield and Londavra, supporting small farmers and their families.

What now? Why can't people be allowed to use the natural resources of land, water and air to live off the land, why are these resources restricted to industrial forestry use or large scale agri-business, whose contribution to the so called triple bottom line of social, environmental and economic benefit at the local level is nil. At least the average family does not call in the helicopters to drop napalm on the valley to clear the land for planting, and poison and shoot the local wildlife, just for starters.

Secondly, the Planning Scheme provides a loophole for plantations, a plantation does not need a permit to be planted on already cleared land. While a permit is needed to clear trees already growing on land, there is another loophole - Council can give a permit to clear trees for converting the land to grazing land or pasture, then when the land is cleared there is no need for a permit to plant a plantation on the now cleared land!

The combination of this zoning and these loopholes means that small land owners can't easily build a house on their properties in the "Natural Resources Zone", but plantations can be planted without any control. People are being replaced by trees.

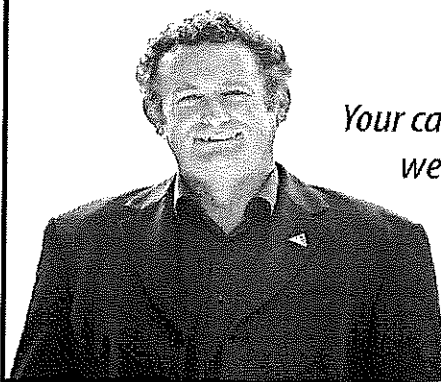
One hundred and fifty years of pioneer work in clearing the land and settlement of the St Marys district, growing a community with a history and a future, is being destroyed by a combination of corporate greed, Federal and State Government indifference to the impact of their big picture policies on small local communities, maladministration by public servants in failing to fulfill their environmental protection duties, and the failure of the Break O'Day Council to fulfill its duty to protect the health, safety and welfare of residents by amending its Planning Scheme.

I am more than happy to discuss the matter with anybody. Telephone calls (6372 2647) will usually get me after 6.00 pm, or you might like to call other local Councillors to get their views, a balance to what might be considered my extremism.

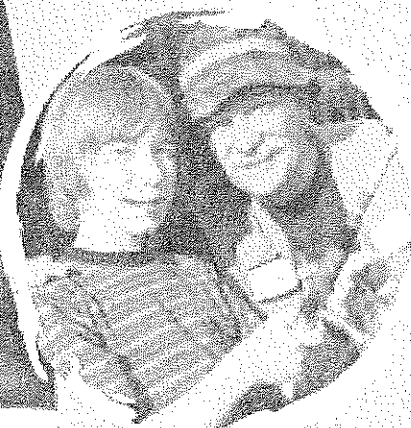

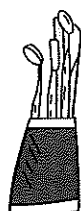

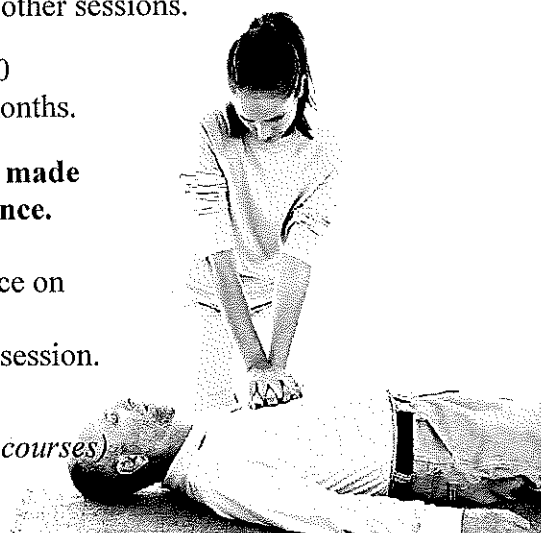

# NEET SKI TRIP

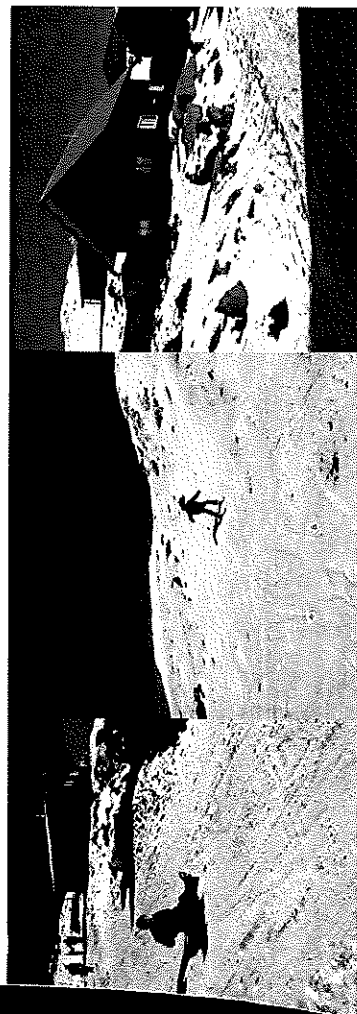

If one of your family or friends had a stroke would you know what to do? Would you even know how to recognise if it might be a stroke?

Stroke is Australia's second biggest killer and recent studies have shown 15 per cent of people do not recognise any of the symptoms.



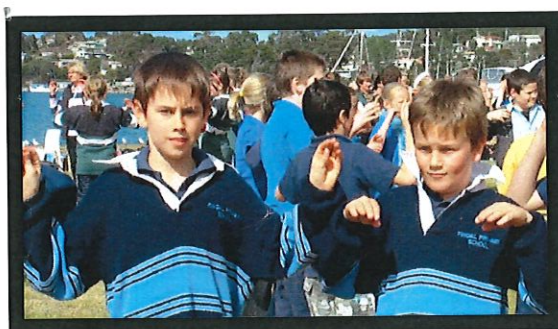

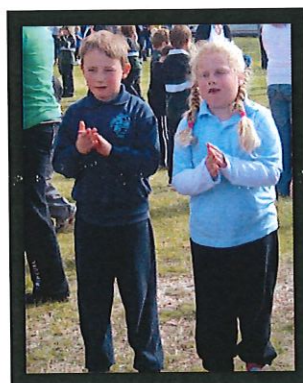


## Dance Day at St Helens

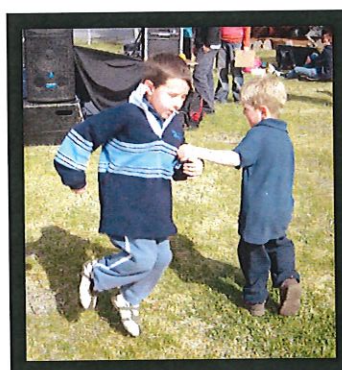

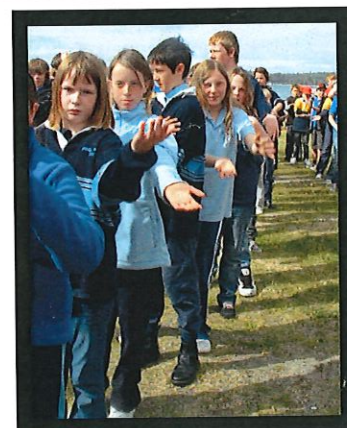

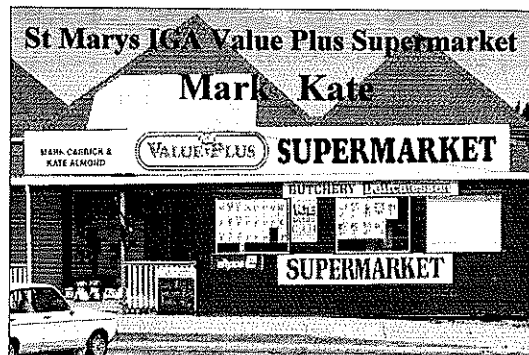
