## EDITORIAL

### ST. MARYS' FLOOD PROBLEMS

On Tuesday 13th August, twenty persons (one was a lady) met at the St. Marys' Community Hall to discuss flood damage relating to the infamous Newman's Bridge at The Flat and the St. Marys' Rivulet.

The meeting was called by the Fingal Council to determine the mind of the ratepayers and for assistance for the Council in its dilemma regarding the problems above.

The Warden, Cr. Haas, introduced representatives of the P.W.D. and the Rivers and Waters Commission, as well as Mr. Polley M.H.A. and Mr. George Shaw M.L.C.

Others attending were local ward Councillors, ratepayers who had petitioned the Council, and other interested persons. As can be deduced from the above information those attending the meeting other than visitors and Council personnel numbered less than 50% of the total attendance—a very disappointing fact. However a good cross—section of affected ratepayers was present and a worthwhile meeting ensued.

NEWMAN'S BRIDGE The P.W.D. men were well received and cuite sympathetic to the problem of the bridge particularly and to the flood question in general. They showed clearly that in this specific problem they were willing and able to help and this was seen by the meeting to be an extension of their prompt and efficient action in previous weeks regarding flood damage in the area.

The P.W.D. had previously asked Council what it recommended re. Newman's Bridge. Council had suggested that a low-level bridge be erected and the P.W.D. had itself suggested that a ford be placed there. The existing bridge acted as a natural dam as logs and other debris piled up against it.

P.W.D. representatives said they had no opposition to the building of a ford but pointed out that grades into residents' garages would be too steep.

The proposal to raise the level of the bridge (minus debris-collecting railings) was seen to be the better solution and

finally members of the meeting agreed with Mr. Polley's suggestion, "that the bridge be removed or dismantled until work can proceed". This may mean some incomvenience to the Flat residents but could prove to be a wise move should another flood occur.

ST. MARYS' RIVULET The Rivulet was seen by local; to be the biggest flood problem and somehow the meeting got off on the wrong foot with the Rivers and Waters Commission representative. Some reacted strongly to some of his comments and in the heat of emotion misunderstood what he was trying to say.

It is this writer's opinion that the representative made pertinent and generally accurate comments concerning the Rivulet. He did not attempt to repute the contention that the dirty and overgrown Rivulet was a major contributing factor in the extensive flood damage earlier this year. He stated further that "the flood had done a service in cleaning out the Rivulet so willows can be got at..... Whatever we do will not cater for these kinds of flood; even if perfectly clean, logs will continue to block bridges.... it cant give protection for this kind of flood."

The spokesman made it clear that the Commission is prepared to undertake Continued on Page 2.

#### YOU AND THE LAW

Most families today have a pet, and in particular the favourite pet seems to be a dog of varying sizes and breeds, but I wonder how many dog owners realise just what problems a dog can cause for the owner.

Only last week, dogs attacked a flock of sheep at Scamander, killing four and as a result of Police enquiries, one of the killer dogs was located and destroyed.

For those people who awn or keep a dog, I want to make it quite clear that the law has laid down regulations to deal with straying or killer dogs. For the information of dog owners and sheep farmers I draw to their attention the requirements of the law controlling dogs.

It is the responsibility of the owner or keeper of any dog, to ensure that the dog is not allowed, at any time, to leave the property of the owner unless the dog is on a lead or under the immediate control of the owner or some competent person.

Dogs are not permitted to roam around the streets, or to enter upon the property of other; at any time, night or day, unless the consent of the property owner is first obtained and even then the dog must be, at all times under the immediate control of its owner or its keeper or some other competent person.

So if you are the owner of a dog, then it is up to you to keep your dog on your own property or under your immediate control. Failure to do so could result in a fine of \$30.00

Sheep owners have the right to destroy any dog sighted worrying or killing sheep, in fact any person who finds a dog killing sheep has the right to destroy the dog. It is not restricted to sheep owners.

The owner of any dog that kills sheep, must deliver up the dog upon a demand being made to him by a police officer to have the animal destroyed and failure to deliver up the animal can result in prosecution as well as having the dog destroyed.

Dog, it is said, is man's best friend but they can be a nuisance and a destroyer of property, so keep your dogs in your own back yard, off the streets and you will keep the animal out of trouble and stop it from being a nuisance to others.

#### Re. Government Medical Officer at Fingal

As you are aware the Fingal A.L.P. Branch has been doing its utmost to have a Government Medical Officer appointed to reside in Fingal. The initial move for such an appointment must come from the Fingal Municipal Council. Once the Council has decided to favour the scheme it can then invite the Government to establish the scheme.

Sometime in the future it is understood that the Fingal Municipal Council will seek the opinion of ratepayers in Town, Tower Hill and St. Pauls wards as to whether or not the scheme should be established. These ratepayers will be directly involved as contributors to the scheme.

What does such a scheme offer that hitherto has been lacking in the area? :-

- 1. It will provide ratepayers and their dependants free medical consultation between specified hours.
- 2. It should ensure that a medical officer is resident in the Fingal Valley at all times.
- 3. It will ease the heavy loading on other medical practitioners in adjoining areas.
- 4. It should make out-of-hours rostering much more affective than at present.
- 5. It will mean that during an emergency such as an accident, or a person suddenly taken ill, trained medical help will be closer.

It is envisaged that the cost to ratepayers in the Wards mentioned would be approximately 2.5¢ in the dollar of Annual Value. This is an opportunity to have a medical officer residing in the area at minimal cost. A rejection of the scheme now could probably mean a rejection for all time. Health service of this type is surely far too important to be rejected. Residents should act now to have the scheme adopted by informing Councillors individually, or, the Fingal Municipal Council that you are in favour of the scheme. Failure to do this could mean the scheme will never be adopted.

Members of the Fingal A.L.P. Branch have already presented a petition bearing 445 signatures requesting the Fingal Municipal Council to appoint a resident medical officer for Fingal. Letters from residents should make such an appointment a reality.

For further information regarding the appointment of a medical officer please do not hesitate to contact members of the Branch.

## just yarnin

It is not often that one is able to check one's story in our 'yarns' with folk who are only second generation from pioneers of the 1850's, but in the case of that William Lade who landed at "Mariposa" last century the story has been seen by his son Mr. Stanley Lade of Launceston, and his comments asked for.

In his letter Mr. Lade remarks that the date of arrival of his father was 1851, not 1829, and that after having worked in Hobart for Andrew Mather, William Lade then moved up to Falmouth where he was financed by his former employer in a store as was stated in our story. Later on he developed properties at Ringarooma and at Scottsdale. There is a tombstone here in the cemetary at Falmouth of an Arthur Lade, but the inscription is now very faint.

The John Lade who had a flour mill at St. Marys was William Lade's younger brother, who later on moved to the N.W. Coast where he farmed. William Lade's sister Amelia was the first Mrs. Fedgman of Hobart.

Mr. Stanley Lade states that he was born when his father was 72 years old in 1902 and Mr. William Lade died in 1905, so links with what we lock upon as our history are really very short.

With regard to the story in a previous issue perhaps it could be mentioned this time that the person who wrote the story was Jack Strochnetter. This may not be difficult since there is his other tale to be told.
